PERSONAL EXPRESSION

COUNCILWOMAN NOLAN requests the privilege of the floor to speak on a point of personal expression and states:

"It is unfortunate that I have to get up this evening to speak about programs very dear to many of our hearts. After receiving over 50 letters from some of my constituents, both students and teachers, concerning the Adult Literacy Program at the YMCA, I brought it up at the last Finance Committee meeting with the School Department. I heard the Superintendent say that she wished to put the money into the K-12 grades and hire reading specialists. I just want to say that a parent learning to read and able to help their child with their reading, writing and their math, is a wonderful thing, and that is part of what the Adult Learning Center has accomplished. The Chairwoman of the School Committee said that the School Board hadn't voted yet and that they might not vote to eliminate these programs. Today I heard that a decision was made not to apply for the funding for the summer program with over 500 students. Three thousand parents have gone through these programs. I also heard today that Head Start and other programs very dear to our hearts, also would be affected by these cuts. The Superintendent feels that in other cities the city

pays for these types of programs. Superintendent, the School Department is the city. We are one. The last time I looked at the Charter, it definitely said that the School Department was part of the city, and if the cost of these programs are moved over to the city budget, how much of a tax increase should we expect. Many of these are programs that we can't afford to let go. While we decided early on to support the Superintendent and let her do her job, some of you had some problems with the neighborhood school project, and I even urged some of you to give the School Department a chance. It couldn't be as bad as it was last year with registration. As far as I am concerned, the honeymoon is over. Why the Superintendent would make these serious decisions without at least talking to the city council, I will never know. I thought we were partners in reform and a good education for our children. I will reluctantly vote for the compact tonight, although what the state did with the residency, I am not so sure that I really want to. But I will reluctantly vote for it. I urge the Finance Committee to investigate all of the agencies that will be cut very carefully, and if necessary, put funds in a contingency account to support these important programs. Thank you."
