



Dear Council President Lombardi:


Once again we are upon the annual Cambodian New Year's Celebration and Festivities at the Wathormikaram Buddhist Temple on Hanover Street. I respectfully asked that you assist us, as you have in the past, in ensuring that the daily celebrations go off without a hitch. We have submitted letters to the Providence Police Department Planning and Policy Office and Irene Testa of the Traffic Engineering Department with our intentions. We respectfully request to have Hanover Street converted into a temporary one-way street on the following dates and times:

Saturday	April 13, 2002	8:30 am- 3:30 PM
Sunday	April 14, 2002	8:30 am- 3:30 PM

As in the past, we intend to keep a free flow of traffic by not causing any undo hardship on any of the neighboring residents, by snarling up Hanover Street with vehicles. We will have three of our security personnel on hand to make sure that festival participants park in the designated parking lots associated with the Temple. We will also make sure that a clear and safe passage is available at all times for emergency vehicles. If at all possible, could we please have two "DO NOT ENTER" signs posted at the intersection of Hanover and Dexter Streets, and two "ONE WAY" signs posted at the intersection of Hanover and Cranston Streets.
