#### RELEASE OF LAND ON GANO STREET TO INTERNATIONAL UNION OF OPERATING ENGINEERS, LOCAL 57

- At the City Council Meeting of June 5, 1958 a Resolution leasing land on Gano Street to the International Union of operating Engineers, Local 57, was introduced, Read and Passed
- On June 6, 1958, this Resolution was vetoed by Mayor Reynolds, due to the fact that mandatory referral to City plan Commission had not been complied with.
- City Plan Commission report, having been received, the Resolution (No. 325) was returned to the City Council at the meeting of July 3, 1958, whereupon it was adopted and approved by His Honor, the Mayor.
