

RESOLUTION OF THE CITY COUNCIL

No. 399

Approved June 9, 1993

RESOLVED, DECREED AND ORDERED:

That the following named street shown as cross-hatched area on the accompanying plan entitled: "Providence, RI Department of Public Works - Engineering Office, Street Line Section Plan No. 064543 dated April 7, 1993 and Plan No. 064544 dated April 12, 1993.

VIZ:

PINE STREET, (portions of), shown as cross-hatched area on accompanying plan and designated by the letters (A-B-C-D-A) having ceased to be useful to the public and is proposed to be abandoned as a Public Highway. Said Abandonment is specifically conditioned precedent upon the following: (1) The City Plan Commission of the City of Providence shall indicate its approval of the within abandonment by letter to the Office of the City Clerk of the City of Providence. (2) Petitioner shall tender the amount of One Hundred Fifty-three Thousand Dollars (\$153,000.00) in legal tender U.S. to the City of Providence. (3) The petitioner shall convey an easement acceptable to the Providence Water Supply Board which will permit retention of its' facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the petitioner shall assume all costs of relocation. (4) The petitioner shall convey an easement acceptable to the Narragansett Electric Company which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the petitioner shall assume all costs of relocation. (5) The petitioner shall, to the approval of the Director of the Department of Public Works, reconstruct the street and curb line for the relevant portions of Pine Street, and the damage to the abutters is appraised at nothing and so awarded. And it is further

ORDERED, That the Traffic Engineer be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City

Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.





Whereas, this Project will provide the Performing Arts Center with a means to future fiscal stability, reducing chances of an operational deficit;




This partnership owns the Jesse Metcalf Building which is directly behind the Providence Performing Arts Center (PPAC), and provides offices for the Department of Employment & Training for the State of Rhode Island on its first four floors. The fifth floor is presently vacant, and a major marketing effort to lease this floor is planned for mid May 1993.

The plan of construction for "PPAC" will seriously hamper the flow of vehicular traffic on a major artery out of the downtown area. The narrowing of the sidewalks on both sides of Pine Street poses an accident hazard to pedestrians. Pedestrian traffic is very intense in this area with 400 employees of DET in the Jesse Metcalf Building and hundreds of DET clients visiting their offices each day. Johnson & Wales University students add to both vehicular traffic and pedestrian traffic in this area which is the hub of their downtown activities.

The "PPAC" build-out of a five plus story brick "blank" wall twelve feet closer to our office building seriously detracts from "views" in offices we are trying very hard to lease to prospective tenants.


These factors impose on our partnership a serious diminution in the value of our property and which we consider a "taking" by the City under condemnation if this abandonment is granted.

The subject property is located behind the Providence Performing Arts Theater and adjacent to the Johnson and Wales's site, between Garnett and Page Street. The property is zoned D1-300 and the Parcels have 660 sq. ft. and 2400 sq. ft.. the theater plans to erect a structure to increase the size of their stage area. Because the petitioner plans to utilize the property to its full potential by erecting a structure the value would be Fair Market Value.

2400 sq. ft. @ 50 per ft. = \$120,000.00 (behind PPAC)

660 sq. ft. @ 50 per ft. = \$ 33,000.00 (behind J. Wales)

CPC REFERRAL NO. 3058 - Abandonment of a portion
of Pine Street

A communication was received from the Committee on Public Works dated March 19, 1993 requesting review and evaluation of the proposed abandonment of a portion of Pine Street, 12 foot wide, adjacent to the Performing Art Center between Garnet and Richmond Streets.

The petitioner is the Performing Arts Center represented by its Chairman Mr. Joseph W. Walsh and its President J. Lynn Singleton.

The petitioners want to increase the depth of the stage by 12 feet, expand the theaters wing space, construct a new dressing room tower, construct an off street loading dock and renovate the backstage electrical/hvac/technical system.

A field inspection revealed that Pine Street is 40 foot wide fully developed public-right-of-way. The proposed reduction of the width of this important public-right-of-way to 28 foot is would have an adverse effect on present and future circulation pattern in the Downcity Providence.

Pine street is a part of major circulatory system around the Downcity core and it will remain as such important public-right-of-way, in the future.

The lack of off-street loading facility at present, cause a temporary closing of Pine street during the time of performances, creating a traffic congestion on the easterly side of Downcity Providence

A certain compromise could be reached: when the off-street loading facility would be constructed, the Pine Street should remain open all the time to the traffic circulation.

There should be a permanent ban of any parking on Pine Street between Garnet and Richmond Streets to allow two lanes of traffic circulation be open all the time on the reduced 28 foot wide right-of-way.

The staff recommends that the Commission advise the Committee on Public Works that the petition may be granted under condition, that two lanes of traffic circulation on the subject portion of Pine Street will be open and available all the time.

Please furnish us two (2) copies of a detailed site plan (scale: 1" = 10'), prepared and certified by a licensed R.I. Professional Land Surveyor, showing the following:

- Corners of existing rear wall of theater with respect to the Pine Street property line.
- Existing PWSB water mains with respect to Pine Street property line between Richmond and Garnet Streets.
- Existing water services from the mains to the properties they serve.
- Curb line, sidewalk, other underground/overhead utilities, drainage, sewers, vents, poles, etc.
- Area of proposed abandonment with dimensions and angles.
- Proposed theater expansion, wing space, dressing room tower, off-street loading dock, exits, sidewalk, etc.
- Layout of remaining Pine Street right-of-way showing curbing, sidewalks, etc.

I want to reemphasize that **these details are critical to our review** because we have two (2) water mains located




This area is already a problem during the normal daily downtown business. Vehicles responding to Unemployment Security consistently park illegal on the street and cause "major" parking problems and traffic jams.

Whenever there is an event at the Providence Performing Arts the street is closed for loading and unloading, which already causes a major traffic problem. If this abandonment takes place the Southerly side of Pine Street would have to be No Parking Anytime Tow Zone, and someone will have to monitor it continually.

When there is an event at PPA the traffic travels West to Page Street, which is blocked off, and at this time the traffic travels South on Page Street to Richmond Street, and then three (3) of every five (5) cars take an illegal right hand turn the wrong way on Friendship Street. Even when Traffic Engineers place a "Road Closed" sign at Dorrance Street and Pine Street, vehicles continue to go around the sign and proceed to the blocked off area of Pine Street and Page Street.

The far reaching problem is that Garnet Street will be closed to traffic for a while, or maybe forever, depending on what is done with the lot at the old OUTLET Building and the old Johnson and Wales building. Another problem which might have to be addressed is when and if Pine Street's direction is changed from West to East, which has been proposed. If the direction is changed, it will still cause a major problem for parking, but at least traffic can turn left onto Richmond Street to Weybosset Street and find their way to Dorrance Street. At this point the direction of Friendship Street will be changed, and we will be back to square one.







