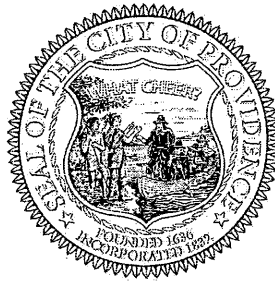

Resolution in Support of the goals of International Women's Day.

**WHEREAS**, On January 7, 2019, Lashonda Hazard, age 27, unexpectedly passed away at Women and Infants Hospital with her unborn child; and

**WHEREAS**, She was refused care and help, treated unfairly and poorly, and made to wait until she died; and

**WHEREAS**, Unfortunately, this is not the only case of Black women in the United States being denied proper treatment and care during pregnancy and childbirth; and

**WHEREAS**, Black women are two hundred forty-three percent (243%) more likely to die from pregnancy or childbirth-related causes, in large part due to a lack of being heard, being seen, and being believed; and

**WHEREAS**, A structural shift is crucial to ensure the health and safety of Black women; and

**WHEREAS**, Black women in Providence, as well as other women of color, are further more uniquely impacted by other issues, such as the current housing crisis and growing wage inequality; and

**WHEREAS**, According to RI Kids Count, a single-parent household with two children needs to earn \$52,932 a year to meet its basic needs; and

**WHEREAS**, However, roughly sixty percent (60%) of Providence households earn less than \$50,000 a year, with thirty-six percent (36%) of households earning less than \$25,000; and

**WHEREAS**, Currently, in Providence, twenty-four percent (24%) of households are families, with forty-two percent (42%) of those households being single women with children; and

**WHEREAS**, Such conditions are a cause of toxic stress for both parents and children, leading to health issues and instability; and

**WHEREAS**, Inequity in wages and income are also an issue that disproportionately impact women of color in Providence; and

**WHEREAS**, Inability to attain a living wage makes housing and living much more unstable for families, particularly single women of color; and

**WHEREAS**, There needs to be a committed fight for a \$15/hour minimum wage; and

**WHEREAS**, However, even that is not enough and a push should also be made for \$20/hour as it currently costs \$31/hour to make living wages in Rhode Island; and

**WHEREAS**, It is important to recognize the Indigenous women and tribes on this land that have been historically and systemically erased but are very much still in full existence; and

**WHEREAS**, Providence is also a sanctuary city that should always be welcome and open to immigrants and refugees; and

**WHEREAS**, Providing protections for immigrant mothers, families, and community members is of the utmost priority, particularly in a time when their rights and humanity are at risk; and

**WHEREAS**, It is imperative to be committed to the cause of women's rights and gender equality, especially and most importantly Black women and women of color; and

**WHEREAS**, There should be a concerted effort to address systemic racism in the City of Providence, especially as it impacts Black women and women of color; and

**WHEREAS**, These issues exist at a national and global level as well; and

**WHEREAS**, Data from The World Bank showed that women, on average, are paid 60 to 75 percent of a man's wage; and

**WHEREAS**, The average gender wage gap is 23 percent around the world, however, this rises to 40 percent for African-American women in the United States; and

**WHEREAS**, According to ActionAid, closing the employment participation gap and wage gap between men and women would increase women's average income, globally, by up to 76 percent, which is calculated to have a global value of \$17 trillion; and

**WHEREAS**, In 1975, the United Nations officially adopted March 8 as International Women's Day to commemorate the movement for women's rights and call for further change in achieving gender equality; and

**WHEREAS**, March 8, 2019 is International Women's Day 2019, a day to celebrate the achievement of women in the past, present, and future and restate commitments to empowering women across the nation and world; and

**WHEREAS**, In particular, it is a day to renew and commit to a focus of listening to, believing, empowering, and following Black women and women of color in the City of Providence.

**NOW, THEREFORE BE IT RESOLVED**, That the Providence City Council supports the goals of International Women's Day and recognizes that the economic, social, and political empowerment of women is linked to the growth, development, and creation of opportunities for every member of society.

***BE IT FURTHER RESOLVED***, That the Providence City Council supports and believes the voices of Black women and women of color in Providence and recognizes the systemic oppression that disproportionately impacts them and commits to addressing those issues to bring equity, stability, and safety to every community member of Providence.

**WHEREAS**, Under the leadership of Head Coach David Guglielmo, the Mount Pleasant High Boys' baseball team reached the Division III championship game; and

**WHEREAS**, The proposed legislation would ensure protections for victims of stalking from gun violence; and

**WHEREAS**, The bill works to close loopholes in federal law as it pertains to stalkers; and

**WHEREAS**, First, the bill includes “dating partner” as a part of the definition for “intimate partner”, ensuring that individuals convicted of dating abuse are unable to have access to firearms; and

**WHEREAS**, Current law only prohibits someone from owning a gun if they are a convicted of abusing a spouse, someone they live with, or someone they have a child with; and

**WHEREAS**, Abuse of a dating partner is as serious an act of violence as domestic abuse and should be treated as such; and

**WHEREAS**, Secondly, the bill would close a loophole that still allows certain convicted stalkers access to firearms; and

**WHEREAS**, According to bill sponsor, Congresswoman Dingell, stalking is a predictor of future violence, as indicated by one study of female murder victims, which highlighted that 76% of women murdered by a current or former intimate partner experienced stalking in the year preceding the murder; and

**WHEREAS**, It would take proactive measures to ensure that any firearm sold, whether by a federally licensed vendor or a private seller, would be subject to background checks; and

**WHEREAS**, This bill would work to ensure all victims of stalking are protected and kept safe from potential stalkers wishing to cause them harm; and

**WHEREAS**, As public servants and the elected representatives of the people of Providence, the City Council has a moral obligation to ensure the safety of its residents and keep firearms out of the hands of stalkers who would seek harm against victims.

Resolution Approving the Proposal of the Mayor requesting the Providence Public Buildings Authority to Issue Bonds to Finance \$30,000,000 Health and Safety Projects at the City's Schools and School Facilities.

**WHEREAS**, The Providence Public Buildings Authority (the "Authority") was constituted as a body corporate and politic of the City of Providence pursuant to the provisions of Chapter 50 of title 45 of the General Laws of Rhode Island (the "Act") and a resolution duly passed by this City Council on August 13, 1987; and

**WHEREAS**, The Authority's creation was approved by the Public Finance Management Board on February 12, 1988; and

**WHEREAS**, The Authority may now duly transact its business of acquiring and constructing public facilities, acquiring public equipment; maintaining, renovating, repairing and operating the same; and issuing its revenue bonds and/or notes to finance the public facilities and public equipment; and

**WHEREAS**, The Authority may develop its projects only upon the request of the Mayor and the City Council; and

**WHEREAS**, Such request must take the form of a proposal by the Mayor approved by the City Council; and

**WHEREAS**, The Mayor has submitted the proposal attached hereto as Exhibits "A", "B" and "C" for the City Council's approval.

**NOW, THEREFORE, BE IT RESOLVED,**

1. That the City Council hereby approves the Proposal of the Mayor dated February 14, 2019 attached hereto (the "Proposal") which, among other things, requests the Authority to use its best efforts to finance the acquisition, design, construction, repair, rehabilitation, replacement and improvement of health and safety projects at the City's schools and school facilities which have been approved by the Rhode island Department of Education, including but not limited to building envelope repair, mechanical, electrical and plumbing improvements, fire code compliance and pest control, including design and feasibility, engineering, City Capital Improvement Projects or other studies which may be necessary in connection therewith and any other acts necessary or incidental thereto (the "Projects").

2. That the City Council hereby authorizes the Mayor to sell and convey Project properties to the Authority and to negotiate and lease the Projects so conveyed from the Authority and to transfer such additional property to the Authority as shall be necessary to provide adequate security for the bonds or notes.

3. That the Mayor, the Director of Finance and the City Treasurer be, and they hereby are, authorized to take any and all action and to execute, file and deliver any and all agreements, notes, deeds, leases and other documents, instruments, and papers, including tax compliance certificates, and amendments thereto, as they, in their sole discretion, may deem necessary or desirable to implement the transaction contemplated by the Proposal.

4. That the City's Department of Public Property shall submit all estimates, bids, etc. regarding such acquisition, design, construction, repair, rehabilitation, replacement and improvement of the Projects to the Committee on Finance of the City Council as such estimates become available.

5. The City's Director of Finance is authorized to execute and deliver continuing disclosure certificates in connection with the bonds or notes issued by the Authority, in such form as shall be deemed advisable by the City's Director of Finance. The City hereby covenants and agrees that it will comply with and carry out all of the provisions of each continuing disclosure certificate, as it may be amended from time to time. Notwithstanding any other provision of this Resolution or the bonds or notes, failure of the City to comply with any continuing disclosure certificate shall not be considered an event of default; however, any bondholder or noteholder may take such actions as may be necessary and appropriate, including seeking mandate or specific performance by court order, to cause the City to comply with its obligations under this Resolution and under any continuing disclosure certificate.

6. This Resolution is an affirmative action of the City Council towards the issuance of the Authority's bonds and/or notes in accordance with the purposes of the laws of the State. This Resolution constitutes the City's declaration of official intent, pursuant to Treasury Regulation § 1.150-2, to reimburse its General Fund in an amount not to exceed Thirty Million and 00/100 Dollars (\$30,000,000) for certain capital expenditures for the Projects paid on or after the date which is sixty (60) days prior to the date of this Resolution but prior to the issuance of the Authority's bonds and/or notes, or otherwise as permitted by such regulation. Amounts to be reimbursed shall be reimbursed not later than eighteen months after (a) the date on which the expenditure is paid or (b) the date the Projects are placed in service or abandoned, but in no event more than three (3) years after the date the expenditure is paid.

7. With respect to the Projects authorized herein, to the extent that the construction of such Projects requires any amendment of the zoning ordinance or zoning map of the City, the City Council hereby initiates the same and directs that the City Planning Commission at its earliest opportunity provide it with its findings and recommendations as provided for in Rhode Island General Laws Section 45-24-52, as amended, and that the City Clerk schedule a public hearing of the City Council with all reasonable dispatch, giving proper notice as prescribed in Rhode Island General Laws Section 45-24-53, for this City Council to act on the proposed amendment.

8. The Thirty Million (\$30,000,000.00) Bond Issuance, as stated above, may be borrowed in one or more bond issues based upon funding efficiencies. All bond issues shall be completed at or near simultaneous closing dates, but no later than June 30, 2019.

9. This Resolution shall take effect on passage.


