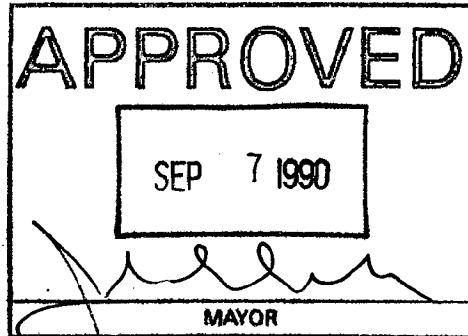

Dear Councilman Rollins,

I am writing to you on behalf of the St. Michael's Parish Community Festival Committee. This year our annual festival will be held on Sunday, September 30, 1990. The festival is held on the church grounds and the adjacent streets. As in the past, I am writing to you to ask that you sponsor the closing of the streets for us for the period of the festival.

This year, we are requesting that Croyland Road from Oxford Street to Sayles Street be closed from 3PM on Saturday, September 29, 1990, to 6:30PM on Sunday, September 30, 1990. This will enable us to set up the booths of the festival on Saturday for the actual event on Sunday. There is only one house on Croyland Road along the stretch we seek to close. That house is on the corner of Croyland and Sayles and access to the home will not be hindered in any way.

In addition to Croyland Road, we also seek to close Oxford Street from Prairie Avenue to Gordon Avenue from 8AM on Sunday September 30, 1990 to 6PM on the same day. We will provide limited access to the housing development across from the Rectory on Oxford Street as we have in the past.

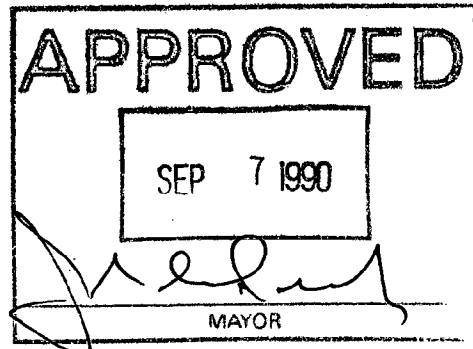

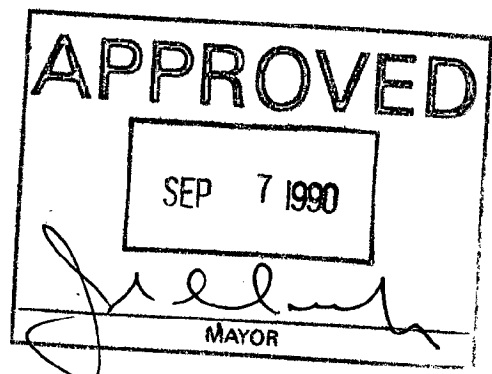
