





COMPLAINT


The City of Providence complains that in said City on the 23rd day of August, A.D., 1990, WAYNE A. MILLER, alias John Doe of the City of Framingham of the Commonwealth of Massachusetts, owner of the premises located at 205 Ocean Street in the City of Providence, and further described as Assessor's Plat 54, Lot 880, did fail to maintain said premises in compliance with an ordinance providing minimum standards for housing, Chapter 13 of the Code of Ordinances of the City of Providence, Approved October 21, 1968, as amended, in that:
