

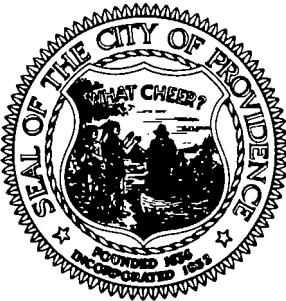
**COUNCILMAN BUTLER, seconded by COUNCILMAN ALLEN Directs the

NOMINATION OF CLERK OF THE PROBATE COURT:


COUNCIL PRESIDENT LOMBARDI calls for Nominations for Clerk of the Probate Court.
