*Whereas*, These structures will undoubtedly be an eyesore to the residents of the area, together with a pollution problem that will exist due to the nature of the construction and

*Whereas*, The construction of a deep pit to store the coal and ash residue left over when said coal is burnt will create an enormous problem inconsistent with the property values along the East Side of our City,

*Now, therefore, be it Resolved*, That the members of the Providence City Council hereby oppose the plans of Newbay Corporation to build a congeneration power project in East Providence.

Resolution Authorizing His Honor the Mayor to enter into a License Agreement regarding the Capital Center Project.

*Whereas*, The City of Providence is a party to the Providence Rail Relocation Project Cooperative Agreement dated January 27, 1982, and the Master Property Conveyance Contract dated December 29, 1982, both agreements being recorded in the Land Evidence Records of the City of Providence; and

*Whereas*, pursuant to said agreements, the City of Providence owns certain property located northerly of Park Row West and westerly of Parcel 8, all within the Capital Center Special Development District in the City of Providence; and

*Whereas*, in order to provide electrical service to the building now being constructed on said Parcel 8 within the Capital Center Project Special Development District, it will be necessary to locate an electrical transformer within the boundaries of the land owned by the City of Providence westerly of said Parcel 8.

*Now, therefore, it is Resolved*: That his Honor the Mayor is authorized to execute a License Agreement with Capital Properties, Inc., permitting the Licensee to use and maintain a concrete pad for the support of an electrical transformer and primary switch upon an area no more than 10'x20' (200 sq. ft.) in size located on land of the City of Providence westerly of said Parcel 8 and northerly of Park Row West, together with the right to run underground electrical lines from Park Row West to the transformer and from the transformer to the building being constructed upon Parcel 8, and

*Be it further Resolved*, That the License Agreement shall include the provision that the City be indemnified from all legal claims that may arise from the installation and presence of the said transformers.
