AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1985-69, APPROVED JUNE 25, 1985, BY TRANSFERRING VARIOUS SUMS OF MONEY WITHIN THE SCHOOL DEPARTMENT.

Be it ordained by the City of Providence:

SECTION: 1 CHAPTER 1985-69 of the Ordinances of the City of Providence, as approved June 25, 1985, entitled: "An Ordinance making an Appropriation of One Hundred Eighty Million, Six Hundred Sixty-Nine Thousand, Three Hundred Ninety Nine Dollars and Eighty Eight Cents (\$180,669,399.88) for the Fiscal Year ending June 30, 1986, as amended" is hereby amended by transferring various sums of money within the School Department. 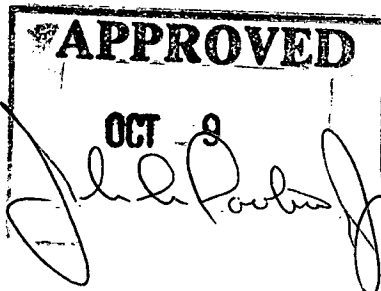
