CHAPTER 1293

No. 513 AN ORDINANCE IN AMENDMENT OF ARTICLE XV OF THE 1946 REVISED ORDINANCES ENTITLED "OFFICERS AND EMPLOYEES GENERALLY".

Approved September 18, 1959

Be it ordained by the City of Providence:

Section 1. Article XV of Revised Ordinances of the City of Providence 1946 entitled "Officers and Employees Generally" is hereby amended by adding thereto the following section:

Sec. 176.4 LEAVE OF ABSENCE FOR EDUCATIONAL TRAINING.

The City Council Committee on Finance may authorize an educational leave of absence at one-half pay to any regular full time employee of the City (except school department employees) who has been so employed for at least two years and who is engaged in specialized or technical work. Such educational leave shall be for the purpose of receiving specialized advanced training in the field of his employment with the City, so that he may perform his duties to the greater advantage of the City. The period of such educational leave shall not exceed nine months and no more than one employee may be on educational leave from the same department at the same time. Such educational leave shall be granted only when a qualified person with the required special training is not otherwise readily available. During such leave, said employee shall be continued on the payroll of his department with all rights and privileges except disability benefits. Department heads may employ temporary help to perform the duties of the individual on leave.

Requests for educational leaves of absence shall be granted only if the Department Head of the applicant approves the application, certifies as to his eligibility hereunder and such application is approved by the Mayor.

Prior to authorization of any such leave of absence for educational purposes, the employee shall furnish to the City in such manner and form as the City Solicitor shall require a bond or other satisfactory written assurance that upon termination of his leave, he will return to and continue employment with the City for at least two years immediately after such termination of leave, or that he will reimburse the City for any moneys paid to him during such educational leave.

Sec. 2. Except as herein above provided, the Finance Committee shall establish all rules and regulations governing such educational leaves of absence and its decision on all matters pertaining to the same shall be final.

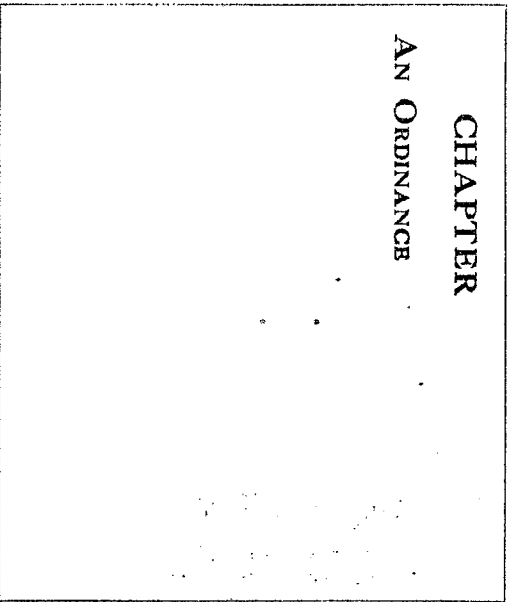

CHAPTER 1294

No. 514 AN ORDINANCE AMENDING CHAPTER 23, SECTION 20
OF THE REVISED ORDINANCES OF THE CITY OF PROVIDENCE, 1946,
REQUIRING A PUBLIC HEARING BEFORE THE ISSUANCE OF A LICENSE
TO A TRAVELLING SHOW, CARNIVAL, CIRCUS, OR MERRY-GO-ROUND.

Approved September 18, 1959

Be it ordained by the City of Providence:

Section 1. Chapter 23, Section 20 of the Revised Ordinances
of the City of Providence, 1946, entitled "Theatres and Shows --
Written Consent to Use Vacant Lot," is amended to read as follows:

"No person shall locate or carry on any travelling
show, carnival, circus, or merry-go-round, upon any
vacant lot within the City, without first securing
a license therefor from the Bureau of Licenses
after a public hearing.

Notice of said public hearing shall be advertised at
least two (2) times in a newspaper published in the
City of Providence prior to such public hearing. "The
advertising fee shall be paid by the applicant". No
application for such license shall be received for
advertising unless the majority of the owners or
occupants of the land within 200 feet of the location
consent in writing to the grant of such license.

Sec. 2. This Ordinance shall take effect upon its passage.

The City Treasurer has received an offer made by Joseph Cicerchia of \$387.52 for Lot No. 192 on Plat No. 110 and as the period for the redemption of this property has expired, this offer is hereby approved in accordance to the law thereto appertaining.

If said real estate shall not be redeemed within thirty days, the City Treasurer is hereby authorized to sell and convey to the said Joseph Cicerchia for the price herein approved.

That the following Minute on the Life and Character of the late John B. Dunn be and the same is hereby adopted and ordered inscribed on the records of the City Council and a copy transmitted to the family of the deceased.

MINUTE

JOHN BERNARD DUNN was born in the City of Providence on May 8, 1891, the son of the late Cornelius J. and Mary J. (Campbell) Dunn. He received his early education in the local public schools, English High School and Morris Heights Academy where he excelled in scholarship and sports. At Brown University, from which he graduated in 1916, he played varsity baseball and was a member of the track team. His fraternity was Pi Kappa and he was active in the student governing body, the Cammarian Club.

He served his country during World War I as a naval officer and had overseas duty for a year and one-half. In 1942, Governor McGrath named him a member of the Board of Trustees of State Colleges. After several years of service, he resigned to give more time to local public duties.

His service to the City of Providence, begun in 1943, was long and varied. Among the duties he assumed were Member and Chairman of the Zoning Board of Review until 1951; Finance Director, 1945-1947; City Treasurer, 1947-1951 and Commissioner of Public Safety, 1951 until his death on September 10, 1959. He sat as a member of the Board of Contract and Supply for more than 14 years.

He was a communicant of St. Pius Church and was signally honored in 1943 by appointment to head the Catholic Charity Fund Appeal.

He served his church, city, state and nation with honor and distinction.

The members of this City Council, in noting the passing of an outstanding citizen express the appreciation of a grateful citizenry and extend to the members of his family their sincere sympathy.
