
This Department is in agreement with the above and is aware at this time of no other reason that would preclude the conditional sale of the land in question.





SUBJECT: Abandonment of Montgomery Avenue

Montgomery Avenue is bisected longitudinally by the Providence-Cranston City Line, half of the street being in Providence and the other half in Cranston. The low point in Narragansett Boulevard is at Montgomery Avenue and the City of Cranston has a storm sewer in Montgomery Avenue between Narragansett Avenue and its easterly termination which conducts the storm water away from this area.

It is therefore recommended that Montgomery Avenue not be abandoned, but retained as a street.

Relative to the abandonment of a portion of Montgomery Avenue, I would like to point out that this street is at the low point in Narragansett Boulevard.

When heavy rains occur, the catch basins in this area will not always take the water which is fed into this area and this street then becomes an overflow. We have two catch basins at the easterly end of Montgomery Avenue which takes this water and diverts it into a drain in the Shipyard area.

I respectfully submit that these facts be given consideration at this hearing to be held on February 16, 1970.




Dear Councilman Payne:

Under date of January 16, 1970, we received a memorandum from the Department of the City Clerk, in which was enclosed a petition to the City Council for the abandonment of a portion of Montgomery Avenue.

The petition was submitted by the Berry-Hill Corporation. After reviewing this petition, we find that our facilities in this section to be abandoned have a depreciated value of \$1,454.85. 




