In accordance with the provisions of Section 406 of the Providence Home Rule Charter of 1980, I, the undersigned, hereby respectfully request you call a Special Meeting of the City Council on Monday, the 2nd Day of July, 1990, at 6:00 o'clock P.M. (EDT).




