No. 637 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1974-19, APPROVED JUNE 19, 1974 BY APPROPRIATING THE SUM OF ONE MILLION FOUR HUNDRED THOUSAND FORTY EIGHT DOLLARS (\$1,400,048.00) TO ITEM 0, VARIOUS DEPARTMENTS (LABORERS, POLICE AND FIRE CONTRACTS).

Be it ordained by the City of Providence:

SECTION 1. Chapter 1974-19 of the Ordinances of the City of Providence, as approved June 19, 1974 entitled: "An Ordinance making appropriation of \$85,823,307.71 for the support of the City Government for the fiscal period beginning July 1, 1974 and ending June 30, 1975" as amended is hereby further amended by appropriating the sum of One Million Four Hundred Thousand Forty Eight Dollars (\$1,400,048.00) to Item 0, in the following Departments:
