
Dear Mrs. Fagnoli:

I am writing to you again as a member of the Elmhurst Arboretum Condominium Association. There was a water main break on Arbor Drive which apparently required the removal of asphalt. Some sort of asphalt was loosely placed on top of the excavation but has long since washed away. Now, a dangerous condition exists on the street because a portion of the street is mud.

Additionally, on the lower part of Arbor Drive, going towards Wyndham, several of the manhole covers are beginning to detach from the asphalt as has happened to others in the last several years. If a permanent resurfacing is not possible, perhaps patchwork repair work that was previously done on the street will have to be tried again.

I realize that the weather has been inclement for these types of repairs, but I wish you would talk to the Department of Public Works to put us on the list for a spring fix.
