




Dear Councilman,

It was a pleasure showing you our new building last week. As you requested, I am summarizing, in writing, our discussion about the naming of the city road leading from Harborside Blvd to our site.

First let me reiterate how appreciative Save The Bay is for the constant support of our project. As you saw last week, the completion of this project represents a major asset for both Save The Bay as an organization and the surrounding community. Our classrooms and community spaces will serve thousands over the coming years and our site will provide public access for our neighbors for the first time in decades.

The current name of the City road to our site is Bayview Drive. While a perfectly suitable and descriptive name, we are concerned with confusion generated because there is an identically named road two blocks south on Allen's Avenue in Cranston and a Bay Street less than a mile north on Allen's Avenue in Providence. This is an unfortunate coincidence, but one that can be solved by simply changing the name.

Since we are the only organization on the road, we suggest changing the name to Save The Bay Drive. As a destination site, receiving at times over 100 school children per day, Save The Bay Drive leaves no room for confusion for bus drivers or delivery services.



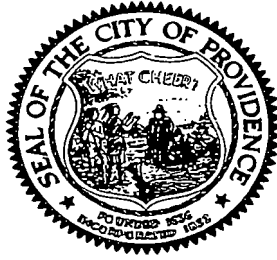
