RESOLVED, That the City Treasurer, acting under the advice and direction of the Commissioners of the Dexter Donation, is hereby authorized to execute a deed of conveyance to Robert E. Dupre, Jr., 78 Hudson Street, Providence, Rhode Island, 02909, for the purchase of Lot 282, as set out and delineated on City Assessor's Plat 32, located along 23 Hammond Street, containing approximately 5,025 square feet of land, more or less, for the total sum of THREE THOUSAND FIVE HUNDRED (\$3,500) DOLLARS, subject to such terms and conditions established by the Committee on City Property, His Honor the Mayor and the City Solicitor, which shall be incorporated into any deed, agreement, or other documents transferring the premises and agreed upon by the parties, and

BE IT FURTHER RESOLVED, That all proceeds from the sale of the land shall be deposited into the Dexter Donation Fund.


IT IS FURTHER RESOLVED, That Resolution No. 378, Approved June 20, 1986, be rescinded.





KNOW ALL MEN BY THESE PRESENTS:

That the CITY OF PROVIDENCE, a municipal corporation, created by act of the General Assembly of the State of Rhode Island, in the County of Providence, in said State, by its agent, STEPHEN T. NAPOLITANO, CITY TREASURER, acting under the advice and direction of the Commissioners of the Dexter Donation, for and in consideration of the sum of THREE THOUSAND FIVE HUNDRED (\$3500) DOLLARS, to it paid by ROBERT E. DUPRE, JR., of the City of Providence, State of Rhode Island, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell and convey unto the said ROBERT E. DUPRE, JR., the following described real estate:

That certain lot or parcel of land lying in said City of Providence, being part of the Dexter Donation land, and bounded and described as follows:

Lot #86 on a plat of lots belonging to the Dexter Donation, recorded in the office of the Recorder of Deeds of said Providence in book of Plat #2, page 7.

Also known as Lot 282 on Assessor's Plat 32.

TO HAVE AND TO HOLD the same, with all the rights, privileges and appurtenances thereof and thereto appertaining, unto and to the use of the said ROBERT E. DUPRE, JR., his successors and assigns forever.

The purpose of this Deed is to convey any interest in the above-described real estate remaining in the said CITY OF PROVIDENCE, which interest was initially acquired by said CITY OF PROVIDENCE under the provisions of the Will of Ebenezer Knight Dexter.
