### **AN ORDINANCE** AMENDING CHAPTER 9 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE ENTITLED "FIRE PREVENTION AND PROTECTION," AS AMENDED

*Approved* February 15, 1994

#### ***Be it ordained by the City of Providence:***

SECTION 1. Chapter 9 of the Code of Ordinances of the City of Providence entitled "Fire Prevention and Protection," is hereby amended to read as follows:

#### **ARTICLE III. CHARGES FOR EMERGENCY MEDICAL SERVICES.**

##### **Section 9-37. Fees.**

Each person receiving emergency medical services in the City of Providence shall be billed for the following fees, if applicable:

1. Advanced Life Support "ALS"	\$ 245.00	one way
2. Base Life Support "BLS"	220.00	one way
3. Cardiac Monitoring	25.00	
4. Defibrillation	180.00	
5. Airways	145.00	
6. I.V.	25.00	
7. Mast Trousers	75.00	
8. Oxygen	40.00	per bottle
9. Mileage ALS	6.00	per mile
10. Mileage BLS	7.00	per mile
11. Miscellaneous Supplies		varies

##### **Section 9-38. Billing.**

The City of Providence may either perform the billing tasks or contract for the services.

##### **Section 9-39. Administration.**

**CHAPTER**

**AN ORDINANCE**

The Commissioner of Public Safety, as head of the fire department, shall make all rules, regulations and policies relative to the implementation of the administration of the billing procedure.

**Section 9-40. Severability.**

The paragraphs, sentences, clauses and phrases of this section are severable, and if any phrase, clause, sentence, or paragraph shall be declared unconstitutional by a valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, or paragraphs of this section, since the same would have been enacted by the city council without the incorporation of any such unconstitutional phrase, clause, sentence, or paragraph.

SECTION 2. This Ordinance shall take effect upon its passage.
