### ELECTION OF JUDGE OF PROBATE COURT

The City Council proceeds to elect a Judge of Probate Court in accordance with the provisions of Section XI of Chapter 3340 of the Public Laws of 1954, approved April 26, 1954 entitled, "An Act in Amendment of Clause I of Section XI of Chapter 598 of the Public Laws, 1866, as amended, relating to the Probate Court of the City of Providence.

Judge Justin P. McCarthy, only nominee, was nominated to succeed himself for the six (6) year term ending on the first Thursday in November, 1965, at open meeting of the City Council held on October 1, 1959 which date allowed for the elapsed time of twenty days between the nomination and the election of a Judge of Probate Court.

On motion of Mr. Gray, seconded by Messrs. Brock, Luongo and Wexler it is voted to take from the Clerk's desk said nomination and elect Judge Justin P. McCarthy to the office of Judge of the Probate Court for the six (6) year term, ending on the first Thursday in November, 1965 by the following roll call vote:
