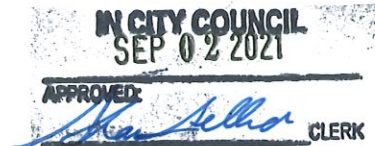

Resolution Regarding Mayor Elorza's License Agreement with Achievement First Rhode Island, Inc.

**WHEREAS**, Mayor Jorge Elorza entered into a License Agreement with Achievement First Rhode Island, Inc. (hereinafter "AFRI") whereby AFRI will rent a portion of the property located at 234 Daboll Street, Providence, Rhode Island, known as the former Charles M. Fortes Elementary School, for the purpose of operating a public charter school beginning Fall of 2021; and

**WHEREAS**, While characterized as a "License Agreement", this agreement is essentially a Lease Agreement; and

**WHEREAS**, Pursuant to Section 416(6) of the City Charter, "Any lease of city-owned real property shall be authorized by resolution of the city council; If the city council does not take any action within forty (40) days of receipt of the proposed lease, the lease shall take effect."; and

**WHEREAS**, City council was never provided a copy of the License Agreement for review; and



**WHEREAS**, There is precedent for City Council invoking its authority on issues such as the leasing of public school buildings to charter schools. In 2015, the International Charter School was interested in leasing space at the Windmill Street School. On March 19, 2015, the City Council reviewed a communication from the Director of Public Property to review the lease of the Windmill Street School Building to the charter school. On May 18, 2015, the City Property Committee reviewed the request. A number of issues were raised, and the City decided not to go forward with the lease. Later, the City Council decided to renovate the building and return it as swing space; and

**WHEREAS**, If the City Council does not intervene and exercise its oversight of this lease, this will create a bad precedent.

**NOW, THEREFORE, BE IT RESOLVED**, That the City Council hereby requests that the Mayor not move forward with the proposed License agreement without first presenting said Agreement to the City Council for review in accordance with the terms of the City Charter, Section 416(6).

**COUNCILMAN GONCALVES**

Resolution regarding Noise Pollution along the Waterfront.

**WHEREAS**, With the lifting of COVID restrictions, the start of summer, and the return to a sense of normality, there has been a recent increase in activity along the waterfront which has resulted in a growing number of complaints from local residents regarding ongoing noise pollution along the waterfront between Providence and East Providence; and

**WHEREAS**, Although the summer season calls for enjoyment and fun, we encourage everyone to be mindful of the other members of the community and avoid loud, unnecessary, excessive, and offensive noise as noise pollution can have direct adverse impacts on public health and diminishes the quality of life for surrounding residents; and

**WHEREAS**, The Providence City Council shares the concerns of the members of the East Providence City Council regarding quality of life issues and is committed to working with our counterparts to ensure that everyone in both cities is able to enjoy their summers without the intrusion of excessive and offensive noise pollution.

**NOW, THEREFORE, BE IT RESOLVED**, That the Providence City Council hereby endorses a collaborative joint city commission consisting of Providence and East Providence elected officials, public safety officials, and constituents to strengthen communication and determine a cohesive and consistent plan of action to mitigate and address noise traveling across the Providence River.

**BE IT FURTHER RESOLVED**, That there is a central web link and location for constituents, both on Providence and East Providence's websites, where dates, times, concerts, events at Bold Point and India Point Park are proactively listed so residents can anticipate, monitor, track and report excessive noise.

**BE IT FURTHER RESOLVED**, That the City Council hereby requests that the Mayor's Administration provide on its website a non-emergency number that constituents can call to report noise complaints, and further create a specific category in 311 dedicated to reporting noise pollution across the river complaints.

***BE IT FURTHER RESOLVED***, That upon passage, copies of this resolution be sent to the Honorable Mayor of Providence, the Commissioner of Public Safety, the Chief of Police, a representative from the Department of Arts Culture and Tourism, the Honorable Mayor of East Providence, the members of the East Providence City Council, and the Chief of the East Providence Police Department, and a Bold Point representative from Live Nation.

Resolution in Support of Mayors for Guaranteed Income.

***WHEREAS***, The COVID-19 pandemic has plunged the United States of America into a public health crisis that has claimed hundreds of thousands of lives, is resulting in historic job loss, and has impacted the life of every single American, all while exposing pre-existing structural issues in local, state, and federal economic systems; and

***WHEREAS***, Prior to the pandemic, nearly 40% of Americans could not afford a single \$400 emergency event, and rising income inequality is compounded by an ever-growing racial wealth divide; and

***WHEREAS***, Research has exposed a growing racial wealth gap in the United States, with the median white worker making 28% more on average than a Black worker, and 35% more than the median Latinx worker in the last quarter of 2019. Moreover, the median wealth of white families is more than \$100,000, while the median wealth of black families is approximately \$10,000; and

***WHEREAS***, The COVID-19 pandemic has dramatically exacerbated these wealth gaps across race and gender, disproportionately affecting Black, Indigenous, People of Color (BIPOC); and

***WHEREAS***, As the elected representatives of the people of Providence, the Providence City Council and Mayor Elorza are committed to addressing these racial and economic inequalities, and have identified guaranteed income programs as one opportunity to do so; and

***WHEREAS***, A guaranteed income (GI) is a monthly cash payment given directly to individuals, with no conditions attached and no work requirements; and

***WHEREAS***, These regular payments have shown to be more effective than unemployment benefits for families of color. Indeed, the data shows that another direct payment would increase Native American, Latinx/Hispanic, and Black family income by 4.1%, 3.9%, and 3.6% respectively, as well as 2% of household income for white families; and

***WHEREAS***, In the Stockton Economic Empowerment Demonstration (SEED), guaranteed income was found to significantly improve recipients' physical and mental health, significantly decrease recipients' income volatility; and

***WHEREAS***, SEED recipients were 12 percentage points more likely to be employed full time at the end of the year than at the beginning of the year, compared to a 5 percentage point increase in the control group; and

***WHEREAS***, A guaranteed income will protect the people and families of Providence, supplement the existing social safety net, and grant them essential protection and agency in controlling their own finances; and

**WHEREAS**, Mayor Elorza has joined Mayors for a Guaranteed Income, a nation-wide coalition of mayors advocating for and piloting guaranteed income programs in their cities; and

**WHEREAS**, The City has established a working group focused on guaranteed income with internal and external stakeholders, including the African American Ambassadors Group, Alliance to Mobilize Our Resistance (AMOR), Direct Action for Rights and Equality (DARE), United Way of Rhode Island, Rhode Island Kids Count, the State Department of Human Services, the Economic Progress Institute, Providence Housing Authority, Providence Youth Student Movement, Rhode Island Foundation, and One Neighborhood Builders; and

**WHEREAS**, The City aims to launch a guaranteed income pilot in the spring of 2021, funded entirely through philanthropic donations; and

**WHEREAS**, Ongoing direct cash payments will put real money in the pockets of residents and have the dual effect of stabilizing families and stimulating the local economy.

**NOW, THEREFORE, BE IT RESOLVED**, That the City Council of the City of Providence does hereby support a monthly, cashed-based guaranteed income program funded entirely through philanthropic donations.

**BE IT FURTHER RESOLVED**, That the City Council hereby requests that the Center for Guaranteed Income Research provide a report to the City Council detailing the outcomes of the Providence Guaranteed Income pilot program.

Resolution Authorizing His Honor the Mayor to execute multiple easements with The Avenue Concept.

IT IS HEREBY RESOLVED, That His Honor, the Mayor, is authorized to grant a surface easement or surface easements over, under, on and upon that area in the City of Providence identified on the easement plan or plans attached hereto (each an "easement area" and collectively, the "easement areas") to The Avenue Concept. Said easement or easements shall be granted specifically upon the following provisions:

1. Said easements shall be utilized only for the installation and display of public art. Said easement shall not exceed the easement area

2. Said easements shall be deemed to run with the land and shall operate against any successors in title and the easements or a memorandum of same shall be recorded by The Avenue Concept in the Office of Land Records for the City of Providence.

3. As consideration for the easements, The Avenue Concept shall install, maintain and display public art in the easement areas for the good of the public and the City of Providence.

4. The Avenue Concept shall execute an indemnification and hold-harmless agreement with the City of Providence. Said agreement shall be approved by the Department of Law of the City of Providence.

5. The Avenue Concept shall supply the City of Providence with an insurance policy naming said City of Providence, its agents, officers, servants and employees as additional-named insureds in a sum not less than one hundred thousand dollars (\$100,000.00) which policy shall be approved by the Department of Law of the City of Providence.

6. In the event that the City of Providence or its designee shall, for any public purpose, require the extinguishment of any easement granted herein, upon ninety (90) days' notice, The Avenue Concept shall, at its own expense, and without claim against the City, its officers, servants or employees, for any damages whatsoever, remove said public art from the designated easement area.

7. To the extent any electrical installations are utilized in any easement area, The Avenue Concept recognizes the applicability of Sections 23-107, 23-108 and 23-190 of the Code of Ordinances which read as follows:

**23-107. Indemnity of city against claims arising out of electrical installations.**

No right of any person to maintain, use or operate any poles, wires, cables, conduits, ducts, pipes, manholes, handholes, or other appliances or appurtenances in any street or other traveled way in the city, shall be in preference or hindrance of public work in the city, and should any of the same in any way interfere with the construction, alteration or repair of any public work in, under, or over any such street or way, whether done by the city directly or by any contractor for the city, such person shall at his own expense protect, alter or move any of the same so interfering to some other location, or discontinue the use and operation thereof for the time being, as directed by the director of public works, without the city being liable for any damages suffered by such person thereby. The City shall notify such person not fewer than ninety (90) days prior to such public work, which will interfere with any of the same or the use or operation thereof. In case such person shall fail to comply with any such direction of said director, the city may protect, alter or move the same, and recover the cost thereof from such person.

**23-108. Precedence of wires, apparatus of city signal service.**

The wires, poles, posts, structures and supports of the telephone, fire alarm and police signal service maintained by the city shall at all times take precedence and right-of-way as to all other wires, poles, posts, structures and supports maintained or erected in the city; and no lineman or other person, either in erecting wires, poles, posts, structures or supports in any way whatsoever shall interfere with, or disturb, disarrange or change any wires maintained by the city, or any appurtenance thereof; and in every instance of removal of any of said wires, poles, posts, structures or supports for the accommodation of any other corporation or party, or to place the same beyond danger from the electric current of any other corporation or party, the expense incident to said removal shall be paid immediately by such other corporation or party.

**23-109. Indemnity of city against claims arising out of electrical installation.**

Every person erecting, maintaining or using electric wires or poles, fixture or structures, for the support or conducting of the same shall indemnify and save harmless the city, its officers, agents and servants, from and against all lawful claims and demands for injuries to persons or property occasioned by the existence of such poles, wires, fixtures or structures or the transmission of electric current by means thereof or by the digging up, opening or keeping open of any street, highway, traveled way, public place or part thereof, which shall be or has been opened for the purpose of installing, constructing or repairing any underground conduit, duct, structure, appliance or appurtenance by or for such person, or by any failure of such person to restore and keep in sound and safe condition for the required time any ground opened or dug up in the prosecution of any of its work in any street, way or place. The city, city council, or the officers, agents or servants of the city, exercising the rights, powers or permission, and subject to the restrictions, respectively given and reserved herein shall not be held liable by such person or corporation on account thereof, or by reason of any injury or damage caused thereby.

8. Such other terms and conditions as may be reflected in the record and minutes of the City Council Committee on Public Works and/or as may be deemed appropriate by the Mayor or the Department of Law.

**FORMER COUNCIL PRESIDENT MATOS AND COUNCILMAN CORREIA**

Resolution Abating Certain Taxes in Compliance with the Donation Agreement for St. Joseph's Hospital.

**WHEREAS**, The City Council, pursuant to Sections 44-3-9 and 44-7-14 of the Rhode Island General Laws, as amended, and Section 21-169 of the City of Providence Code of Ordinances, has the authority to exempt and/or cancel real property taxes as that state and local law prescribes; and

**WHEREAS**, On July 2, 2014, pursuant to the City Council's authority under Section 44-3-9 and Section 21-169, the City approved a tax stabilization in favor of CharterCARE Health Partners to encourage the development of St. Joseph's Hospital and Roger Williams Medical Center, at Chapter 2014-25 No. 315 (the "TSA"); and

**WHEREAS**, On December 28, 2016, Joseph R. Paolino, Jr., in his capacity as a member of 21 Peace Street LLC, a Rhode Island limited liability company (“Peace Street”) and of Urban Land Development Company LLC, a Rhode Island limited liability company (“Urban” and together with Peace Street and Joseph R. Paolino, Jr., collectively “Donor”) purchased St. Joseph’s Hospital. St. Joseph Hospital’s property is comprised of 38 separate tax assessor lots totaling approximately 6.39 acres, improved with two (2) main buildings and several ancillary structures consisting of approximately 276,800 usable square feet and adjacent parking areas and open space commonly and formerly known as St. Joseph’s Hospital (the “Property”); and

**WHEREAS**, Beginning with tax year 2017 (assessment as of December 31, 2016) the City received tax payments pursuant to the payment plan established by the TSA and, at the Donor’s request, began assessing St. Joseph’s Property separately at full and fair cash value. Thereafter, requests were made to reduce the TSA payments dollar for dollar. To date, no amounts have been paid above and beyond the TSA payments and no amendment to the original TSA in favor of CharterCARE has been effectuated. St. Joseph’s taxation is the subject of an ongoing Rhode Island Superior Court lawsuit filed by the Donor against the City of Providence; and

**WHEREAS**, In January of 2020, Donor approached the City and offered to donate significant portions of the Property to the City in order to support the creation of one or more school facilities at the Property (the “Donation Property”); and

**WHEREAS**, The City has identified a need to provide PPSD students with access to additional clean, modern and safe school facilities; and

**WHEREAS**, On August 18, 2020, the City, acting by and through its Mayor, pursuant to Chapter 2, Article II, Section 2-21 of the Providence Code of Ordinances, as amended, entered into a Donation Agreement with respect to the Donation Property in order to develop school facilities to be used to educate PPSD students in grades including pre-kindergarten through eight, on terms set forth in the Donation Agreement; and

**WHEREAS**, pursuant to the terms of the Donation Agreement the Donor has agreed to dismiss the Superior Court lawsuit, with prejudice.

**NOW, THEREFORE, BE IT RESOLVED**, That in order to support the transfer of the Donation Property and the creation of one or more school facilities at the Donation Property, and consistent with both the terms of the Donation Agreement and City Council’s authority under both RIGL §§44-7-14 and 44-3-9 and Section 21-169 of the Providence Code of Ordinances, the City Council hereby:

1. Authorizes the cancellation of taxes assessed and levied against the Donor with respect to the Donation Property for tax years 2017, 2018, 2019, and 2020 (assessments as of December 31, 2016 through and including December 31, 2019), above and beyond payments required under the TSA. Bills to be cancelled are attached as Exhibit A;
2. Authorizes the exemption of taxes beginning January 2020 (Q3 of tax year 2019, assessment as of December 31, 2018) with respect to the Donation Property so long as the Donation Agreement remains in full force and effect. Exempt plats and lots are attached as Exhibit B;
3. Finds that the Donor’s obligation to pay property taxes for the Donation Property for tax years 2017 through, and including, 2019 has been satisfied.

4. Further finds that, beginning with the City's tax assessment as of December 31, 2020 for tax year 2021 and thereafter, any portion of the Property that is not the Donation Property, in accordance with the terms of the Donation Agreement, will no longer benefit from the TSA. Accordingly, the remaining St. Joseph's property shall be assessed at full and fair cash value to the owner of record in accordance with applicable law, without reference to the TSA. Remaining plats and lots to be assessed at Fair Market Value as of December 31, 2020, attached as Exhibit C.
