Dear Mr. Clarkin:

Brown University's 229th Annual Commencement activities will be held from Friday, May 23 through Monday, May 26, 1997. The schedule for major activities is as follows:

Friday, May 23 - 9:00pm-1:30am: Campus Dance, College Green

Saturday, May 24 - 12:00-4:00pm: Alumni Field Day, Aldrich
Dexter Field

Saturday, May 24 - 9:00pm-Midnight: Pops Concert, College
Green

Sunday, May 25 - 9:00am-10:30am: Veterans' Memorial Service
Lincoln Field, Thayer St.

Sunday, May 25 - 12:30pm-3:30pm: Baccalaureate Service,
First Baptist Church

Monday, May 26 - 8:30am-1:30pm: Commencement Exercises

As in previous years, I am again requesting assistance for traffic control for the handling of events during these Commencement activities.

GENERAL TRAFFIC NEEDS/PARKING RESTRICTIONS/STREET CLOSINGS

Prior to 6am, Friday, May 23 through 3pm, Tuesday, May 27, I would request the establishment of a one-way clockwise traffic pattern around the Wriston Quadrangle, that is:

- Charlesfield Street one-way west from Thayer to Brown Street;
- Brown Street one-way north from Charlesfield to George Street;
- George Street one-way east from Brown Street to Thayer Street.
- Benevolent Street will be one-way east from Benefit to Brown Street;
- Magee Street one-way south from George Street to Benevolent Street.

Additionally, I am requesting "NO PARKING ANYTIME" postings as follows for the entire weekend:

- Benevolent Street from Brown to Magee; this should be well posted to prohibit parking on the south side of the street in order to allow for PFD access in case of a fire alarm or emergency medical response.
- Brown Street, east side and west side, from George Street south to Benevolent Street.
- George Street from Prospect to Thayer, both sides, through Tuesday, 5/27. A PPD officer will be posted at George & Brown Streets on Friday, May 23 and Saturday, May 24 from 9:00am-5:00pm to enforce this.
- Waterman Street (south side) from Hope College Gate east to approximately 40 feet past Brown Street from Friday, May 23 at 6:00am through 3:00pm Tuesday, May 27.
- Magee Street from George Street south to Benevolent, both sides.
- Prospect Street, from College Street to Waterman Street (east side) should be posted at 11:00pm on Sunday 25 MAY through 4:00pm Tuesday, 27 May 1997.

SPECIFIC EVENTS

Friday/May 23, Campus Dance & Saturday/May 24, Pops Concert:
The traffic pattern around the Wriston Quadrangle, along with the police officer details, are required for these two events. In addition to the normal traffic pattern as noted on page one, we are requesting to close down George Street between Magee and Brown Street on Friday from 7:30pm until 2:00am, when the Campus Dance ends and on Saturday from 7:30pm until midnight when the Pops Concert ends. In order to accomplish this, at 7:30pm we will close the block to vehicular traffic and we will place a PPD officer at George and Magee to divert all eastbound traffic on George to Magee. This will have to be done in this manner as not to over congest the traffic pattern already established.

From Friday morning, May 23 through 12 noon, Tuesday, May 27, I would request that two-car loading zones be established at the following areas:

1. Williams Street in the rear of 55 Power Street (President Gregorian's residence) adjacent to the removable fence section.
2. Bowen Street, south side, across from 208-214 Bowen Street to facilitate deliveries via Parking Lot #7 to the rear of Andrews Dining Hall.
3. 101 Thayer Street (Thayer Street Quad) to facilitate deliveries to this area.
4. Charlesfield Street/Saunders Gate, opposite 38 Charlesfield Street to facilitate deliveries to Wriston Quad.

Sunday, May 25:

There will be a special procession and commemoration honoring Brown Veterans on Sunday morning, May 25, 1997 beginning at 9:00am. The procession will begin at the rear entrance of the Brown Faculty Club on Benevolent Street, proceed east on Benevolent to Brown Street, cross Brown Street and enter the Wriston Quadrangle. After passing through Wriston Quadrangle the procession will then exit the Quad through the gate east of St. Stephen's Church and march east on George to Thayer, and north on Thayer to Soldier's Arch (opposite 175 Thayer Street).

We are requesting to halt traffic temporarily on Brown Street as the procession crosses over and then to temporarily close George Street until they have rounded the corner onto Thayer Street. We will then close Thayer Street from George to Waterman until the ceremony in Lincoln Field is completed at approximately 10:30am. We will have a PPD officer at the corner of Waterman & Thayer Street to assist. This will not interfere with the traffic pattern that will be established at that time.

Monday, May 26:

I am requesting that you post following areas **"NO PARKING ANYTIME"** by 2300 on Sunday, 5/25 for Monday's Commencement Ceremonies:

1. Benefit Street, east side, from College to Thomas Street until after 11:00am
2. Thomas Street from Benefit to North Main except for limousines.
3. Allow one chartered bus to park on the east side of North Main Street at the front entrance to the Meeting House at 9:45am to transport elderly alumni.
4. Waterman Street (south side) from Hope College Gate to Brown Street.
5. Prospect Street from College to Waterman (east side)

In conjunction with the Commencement procession, I would request that the following streets be closed, with **"STREET CLOSED"** signs, to vehicle traffic from 7:30am until 11:00am:

1. Brown Street at Charlesfield Street (Closed to George)
2. Hopkins Terrace at South Main Street
3. George Street at Benefit Street (Closed to Brown)
4. Benevolent Street at Benefit Street (Closed to Brown)
5. Waterman At Prospect Street (at 0630)
6. Waterman at Thayer Street
7. Thayer at George Street
8. George at Prospect Street (at 0630)
9. Benefit at College Street (at 0630)



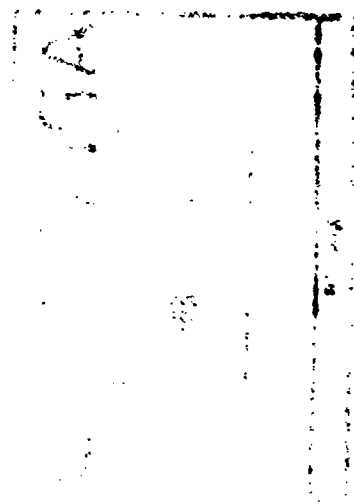
