CHAPTER 1971-1

No. 50 AN ORDINANCE TO AUTHORIZE THE ISSUE OF \$2,400,000 SCHOOL BONDS PURSUANT TO CHAPTER 7 OF THE PUBLIC LAWS OF 1967.

Approved January 21, 1971

Be it ordained by the City of Providence:

SECTION 1. The sum of \$2,400,000 shall be borrowed for the construction, reconstruction, furnishing and equipping of public school buildings. The City Treasurer, with the approval of the Mayor and the Committee on Finance, is authorized to issue \$2,400,000 School Bonds pursuant to Chapter 7 of the Public Laws of 1967 and, subject to the foregoing, to determine the denominations, interest rate or rates, and other terms, conditions and details of the bonds in accordance with law.

SECTION 2. The bonds shall be issued originally as coupon bonds in substantially the form approved by the City Council in Resolution No. 63, approved February 21, 1968. The bonds shall be sold at public sale at not less than par and accrued interest and shall bear such date or dates as the City Council shall determine by resolution and shall be payable in annual installments commencing not later than five years and ending not later than twenty-five years from their date or dates as the City Council shall determine by resolution.

SECTION 3. This ordinance shall take effect upon its passage and all other ordinances or parts thereof inconsistent herewith are hereby repealed.

CHAPTER 1971-2

No. 51 AN ORDINANCE TO AUTHORIZE THE ISSUE OF \$2,000,000 PARKS, PLAYGROUNDS AND RECREATION FACILITIES BONDS PURSUANT TO CHAPTER 118 OF THE PUBLIC LAWS OF 1965.

Approved January 21, 1971

Be it ordained by the City of Providence:

SECTION 1. The sum of \$2,000,000 shall be borrowed for acquiring, developing, equipping and improving public parks, playgrounds and recreation facilities in the City of Providence, including the purchase or condemnation of land for such purposes. The City Treasurer, with the approval of the Mayor and the Committee on Finance, is authorized to issue \$2,000,000 Parks, Playgrounds and Recreation Facilities Bonds pursuant to Chapter 118 of the Public Laws of 1965 and, subject to the foregoing, to determine the denomination, interest rate or rates, and other terms, conditions and details of the bonds in accordance with law.

SECTION 2. The bonds shall be issued originally as coupon bonds in substantially the form approved by the City Council in Resolution No. 63, approved February 21, 1968. The bonds shall be sold at public sale at not less than par and accrued interest and shall bear such date or dates as the City Council shall determine by resolution and shall be payable in annual installments commencing not later than five years and ending not later than twenty-five years from their date or dates as the City Council shall determine by resolution.

SECTION 3. This ordinance shall take effect upon its passage and all other ordinances or parts thereof inconsistent herewith are hereby repealed.



No. 52 AN ORDINANCE TO AUTHORIZE THE ISSUE OF \$1,500,000 SCHOOL BONDS PURSUANT TO CHAPTER 185 OF THE PUBLIC LAWS OF 1962.

Approved January 21, 1971

Be it ordained by the City of Providence:

SECTION 1. The sum of \$1,500,000 shall be borrowed for the purchase of land for public school purposes and/or the construction, furnishing and equipping of public school buildings. The City Treasurer, with the approval of the Mayor and the Committee on Finance, is authorized to issue \$1,500,000 School Bonds pursuant to Chapter 185 of the Public Laws of 1962 and, subject to the foregoing, to determine the denominations, interest rate or rates, and other terms, conditions and details of the bonds in accordance with law.

SECTION 2. The bonds shall be issued originally as coupon bonds in substantially the form approved by the City Council in Resolution No. 63, approved February 21, 1968. The bonds shall be sold at public sale at not less than par and accrued interest and shall bear such date or dates as the City Council shall determine by resolution and shall be payable in annual installments commencing not later than five years and ending not later than twenty-five years from their date or dates as the City Council shall determine by resolution.

SECTION 3. This ordinance shall take effect upon its passage and all other ordinances or parts thereof inconsistent herewith are hereby repealed.
