WHEREAS, Council President Evelyn V. Fagnoli has, pursuant to Sections 406 and 803 of the Providence Home Rule Charter of 1980, requested the City Clerk, in writing, to Call a Special Meeting of the City Council to be held on the 23rd day of July, A.D., 1998 at 7:00 o'clock P.M. for the purpose of Enacting the following:

An Ordinance Providing for the Assessment and Collection of 1998 Taxes in a Sum not less than One Hundred Eighty Nine Million Dollars (\$189,000,000) and not more than Two Hundred Nine Million Dollars (\$209,000,000) Being Based on a One Hundred Percent (100%) of the 1998-1999 Fiscal Year Tax Collections.

An Ordinance in Amendment of Chapter 1997-42, Approved July 25, 1997, of the Ordinances of the City of Providence making an Appropriation of Three Hundred Eighty Three Million, Five Hundred Sixty Three Thousand, Six Hundred Sixty Eight Dollars (\$383,563,668) for the Fiscal Year Ending June 30, 1999, as Amended.




