

**RE: SPEED LUMPS ON CARLETON AND FAIRVIEW**


In response to a City Council Request on January 30, 2017, regarding installing speed lumps on Carleton Street, and Fairview Street, The Providence Department of Public Works Traffic Engineering Division has estimated the cost as follows:

Fairview from Lynch to Pemberton-3 speed lumps recommended total estimated cost \$12,000.00.  
Carleton from Atwells to Chalkstone-5 speed lumps recommended total estimated cost \$20,000.00.

The prices assume this work is incorporated in a larger construction bid.
