No. 66 AN ORDINANCE IN AMENDMENT OF SECTION 30 OF CHAPTER 1981-40, EFFECTIVE JULY 20, 1981, ENTITLED, "AN ORDINANCE ESTABLISHING THE CLASSES OF POSITIONS, THE MAXIMUM NUMBER OF EMPLOYEES AND THE NUMBER OF EMPLOYEES IN CERTAIN CLASSES IN THE CITY DEPARTMENTS", RELATIVE TO DEPARTMENT OF PUBLIC WORKS - ENGINEERING OFFICE.

Be it ordained by the City of Providence:

SECTION 1. Section 30 of Chapter 1981-40 of the Ordinances of the City of Providence, entitled: An Ordinance Establishing the Classes of Positions, the Maximum Number of Employees and the Number of Employees in Certain Classes in the City Departments, as amended, is hereby further amended, as follows:

Add: 1 Mechanical Engineer

That section shall hereafter read:

The number of Employees in the Department of Public Works - Engineering Office shall not exceed twenty-five (25). There shall be no more than:


