To the Honorable The City Council of Providence

Honorable Gentlemen:

The City Council Resolution of December 3, 1959, requesting the Chief of Police to provide a school crossing guard at the intersection of Cole and Laurel Avenues, was referred to the Chief for investigation and recommendation. The Chief reports that thorough investigation was made by officers of the Juvenile Division. Lieutenant May is of the opinion that the situation does not warrant posting a crossing guard. The Chief concurs in this recommendation.

The investigation reveals the following:

1. There are four marked crosswalks at this location, and a clearly visible "Drive Slow School" sign is posted on a pole located on the west side of Cole Avenue.
2. Auto traffic is light on both Cole and Laurel Avenues.
3. From 12:00 noon to 3:30 P.M., a man from the Traffic Division patrols the area on a three-wheel motorcycle.

4. Before and after school, morning and afternoon a well-trained School Safety Squad of 5 pupils, equipped with white belts and rain gear, is on duty. Miss Joyce, principal of John Howland School, says the job done by the Traffic Motorcycleman and the Safety Squad is excellent and that all her pupils are amply protected while crossing the street.

Mr. Elliot Olevson, President of Wayland Square Businessmen's Association, who drives his child to this school, confirms the excellence of the job being done.

The Chief's report ends with the following statement:

"....It is my opinion that at the present time this intersection is well under control and does not need a Crossing Guard at this location."

5. From 8:15 to 9:00 A.M. approximately 80 pupils cross this intersection. Another 100 go directly from autos to the schoolyard. From 12:00 noon to 12:15 P.M., about 120 pupils cross and 60 go directly to cars. From 12:45 P.M. to 1:15 P.M. about 85 cross at the intersection and 105 come from autos directly into the schoolyard. From 3:15 P.M. to 3:45 P.M. about 112 pupils cross and 75 go directly into autos. The above figures remained fairly constant for the two days of inspection.


ELECTION OF A COMMISSIONER OF ESTATE OF CHARLES H. SMITH
