Dear Sir:

With the compilation of figures completed for the calender year of 1957, it is my pleasure to submit, for your inspection, the Annual Report of the Police Department.

Crime in the United States reached an all-time high for the calender year of 1956 and the latest published figures by the Federal Bureau of Investigation for the first six months of 1957 reveal an 8.4% increase over the established high. This increase nationally was brought about by a rise in all serious Part I offenses. Inspection of our figures will indicate that this was not true in Providence and that we experienced a decrease in the major crimes of Murder, Manslaughter, Rape, Robbery, Aggravated Assault and Larceny.

The intensive safety campaigns conducted by the Mayor's Traffic Committee, and this Department, have concretely manifested themselves by a reduction in traffic accidents for the second consecutive year and a decrease in fatalities over 1956.

With the ever increasing potential of the criminal elements coming into this city, it was determined that the detectives should be graded and a school established to train them in the very latest methods of crime detection. In this respect, the services of the top law enforcement agency in the United States, The Federal Bureau of Investigation, was requested and they graciously consented to put on a course of instruction for the men selected. This selection was by means of competitive examination and those chosen were detailed to the Training School where, for two weeks, the FBI put on an intensified course of modern and scientific criminal investigation. The various phases were covered in the class room and practical exercises were conducted in the field. An examination was given at the conclusion of the course.

It should be noted that the morale of the Department has been very high and this may be attributed to the substantial pay increases granted during the past year and the constant improvement of working conditions.

For the first time in years, the Department is approaching full strength and it is planned that the calender year of 1958 will see more extensive police protection for the city an an expansion of services rendered by the Police Department.







NOTE:

The item listing total runs covers complete investigation of crime scenes requiring from two to four or more hours each. It does not reflect the tremendous number of hours required to process the evidence obtained, and the many hours expended in Court appearances.

While the total overtime hours resulting from night calls for B.C.I. personnel is listed as four hundred and twenty-one hours (421) worked, more than one-third of these calls are after midnight. This results in loss of sleep for many additional hours. Under the present manpower quota of four men, providing immediately available services on an around the clock basis, the per diem effective strength is 2.6 men. Due to these circumstances the overtime hours worked cannot be compensated for by compensatory time off without seriously curtailing the services of this Bureau.

In addition to the performance of the duties listed above a considerable amount of studying, and attendance at special courses of instruction is required of the B.C.I. personnel to keep abreast of current developments and to maintain the high standards of technical knowledge expected of this Bureau.

AMUSEMENT INSPECTOR

Many fine Operas Dramas Comedies Ballets and plays were presented in the above auditoriums.

Reviews of Motion Pictures and Legitimate stage productions together with their entertainment value have been received under subscription from:

- Variety (Trade Newspaper)

The Reviews contained therein have been recorded alphabetically and numerically in the Library of this Office for immediate reference.

Accompanied by Sergt. William A. Leonard, Assistant Amusement Inspector, attended eleven (11) private screenings of Foreign Films not having the approval of the Producers Code Authority nor the Legion of Decency and after objectionable portions had been deleted, approval for public exhibition of eight of these films was granted. By agreement reached with the management of the Theatre, application for the showing of three of these films was withheld.

Approval of the Showing of the films " Lady Chatterly's Lover " and the film " And God Created Woman " were denied.

AMUSEMENT INSPECTOR (con't)

The highly controversial moving picture " Baby Doll " was screened by a board of review comprised of the members of the Bureau of Licenses, an Ass't City Solicitor, Commander of the License Investigation Bureau and the Amusement Inspector. After many deletions had been agreed to, approval for its public showing was granted.

Class B licensed places presenting vaudeville acts, submitted reports as to the type of entertainment contracted for and the names of performers appearing and the type of costumes to be worn before appraisal.

Periodic visits were made to the various places of Entertainment to insure compliance with the laws and regulations applicable.

Merchandise of an obscene and objectionable nature found displayed in the window of a downtown store was ordered removed after samples were seized. A second downtown store owner was ordered to remove objectionable merchandise displayed.

In cooperation with the State appointed Rhode Island Commission on Youth letters were received in eleven instances naming 36 magazines as objectionable for youths under 18 years of age for 'sale' , 'distribution' and display, resulting in hundreds of visits to news stands throughout the city.

The local distributor of magazines together with the may newsdealers gave their full cooperation. In one instance where refusal was met after the dealer had been warned and many complaints received in this Office arrest of the dealer resulted and his being charged with " Selling indecent and obscene Magazines " and an indictment being returned by the Grand Jury.

BUREAU OF PERSONNEL AND TRAINING

Recruit School:

During the year 1957 two recruit schools were conducted at this division. The Nineteenth School started March 3, 1957 and the training course was completed September 1, 1957. The Twentieth School started July 7, 1957 and will complete their training January 5, 1958. A total of 24 men were recruited in these two schools during the year. Present figures indicate a shortage of 43 patrolmen, but when the men from this 20th School are appointed 4th grade patrolmen January 5, this figure will be reduced to 29. Plans have reached a stage whereupon the 21st School will start January 6, 1958 with a total of 23 trainees. This will reduce our vacancies to a point, where if the trend of the past 6 months continues relative to retirements and resignations, this department should reach full strength before the end of the year.

School Crossing Guards:

Resignations from this branch of the service were slightly above normal, but this was due to 7 transfers to the newly created position of Women Parking Checkers. This type of work continues to prove very attractive as a parttime position and we have no difficulty in filling vacancies. Four more positions were added to the strength of authorized personnel which now makes a total of 70 Crossing Guards engaged in this type of work. The department continues to receive favorable comment from the public and administrators of this department for the efficient manner in which they carry out their assignments.

Promotional School

During the year 1957 a promotional school was conducted for Patrolmen seeking to be promoted to the rank of Sergeant. A total of 124 applications were received for admission to this school. After a series of tests consisting of an I.Q. Examination, written test on Police matters and an oral interview, 21 were selected to attend this school. Upon the completion of this course, 20 of these men were certified for promotion. From this certified list 9 of these men have received their promotion leaving a balance of 11 awaiting promotion.

Detective I Grade:

During the past year a new grade of Detective I was established after proper authorization from the City Council. A total of 7 men holding this rank is the figure established. After being tested through an I.Q. Examination 15 men were selected to attend a school which started December 2, and terminated December 13 in order to obtain certification for appointment to this rank. This department was very fortunate in being able to obtain a group of men from the F.B.I. Office in Boston to lecture at this school. Men attending this school were given the insight on advanced techniques of police procedures and investigations that should prove very beneficial to this department. Upon the completion of this course 13 men were certified for appointment to this rank. As of this date 2 of these men have received this appointment.

Women Parking Checkers

This department took another step forward by obtaining authorization for 12 Women Parking Checkers to work in the down-town business area, thereby releasing men to concentrate on other police duties in the outlying districts. This is a part time assignment in which these women work 4 hours a day, alternating mornings and afternoons. They are primarily engaged in tagging vehicles for violations of the Traffic Regulations, and have no other police powers, except to render assistance where they can to the public.

Auxiliary Police and Police Reserves

Again this unit proved how valuable they are to the department by participating in the Civilian Defense Operation " Alert " by doing Traffic Control duty at the Scituate Headquarters during this drill. They also furnished men for details, Fourt of July, and Halloween, in which they patrolled selected trouble spots. By the assistance this department received from this unit vandalism was held to a minimum. The department and city are very fortunate in having such a well drilled organization that they can call upon during an emergency.

ACCIDENT PREVENTION BUREAU

As in past years, the Accident Prevention Bureau allied itself with the Mayor's Traffic Safety Committee, and the whole-hearted cooperation the Committee and this Department received from the local press, radio and television stations and the various civic groups, contributed, to a marked degree, in keeping the number of highway fatalities and accidents to a minimum, and the record in that direction was better than 1956.

SPECIAL ACTIVITIES

Sunday April 29th. was "Lion's Safety Day" which culminated the service club's safe driving campaign.

Members of this department assisted the Lions. Passing motorists were handed certificates similar to the state driver's license, except they contained a safe driving message and a pledge to avoid accidents.

SAFETY LETTERS

With the opening of the new school year, it was necessary to alert the school children to the dangers of traffic accidents. This applied especially to the younger children. Letters including a pledge, which was to be shared by the student's family as well, were prepared and distributed to the school children by members of the Juvenile Bureau who lecture in the schools on Traffic Safety. The letter was co-signed by the Chief and the student in an attempt to add a personal touch and give the child a feeling of cooperation.



1956 & 1957





JUVENILE BUREAU

During the year of 1957, members of the Juvenile Bureau lectured on traffic safety in the schools throughout the city of Providence. They gave 356 safety talks to the children on Traffic Safety Education and safety letters were distributed to children in the lower grades. This aided greatly in keeping our accident record, involving children to a minimum. There was only one child pedestrian killed and that was a child of pre-school age.

Forty-nine lectures were given by the Juvenile Bureau to church groups and civic organizations on The Functions and Operations of the Juvenile Bureau.

Our Junior Police Officers supervise baseball, touch football and basketball, playing against leagues sponsored by the Recreation Department of the city of Providence, Boys Clubs and the Providence Journal-Bulletin Community League. A keen, but friendly, rivalry exists between the Junior Police teams and outside teams.

During the summer months, the city of Providence operates the Junior Police Camp located at Point Judith, R.I. Each year, 400 boys spend a period of two weeks each at this camp at no expense to them as all expenses are paid by the city. This camp is situated right on the seashore and the average weight gained by the boys during their stay is 5-10 pounds. They are all underprivileged boys that attend this camp. All recreation at the camp is supervised by the members of the Juvenile Bureau, and the entire camp is under the direction of the Director of Recreation of the city of Providence. There is approximately \$20,000.00 appropriated annually for the operation of this camp.

On Halloween night, the members of the Juvenile Bureau play host to approximately 9,000 boys and girls at parties throughout the city. These parties are sponsored by the local merchants; and, as a result of the parties, the day after Halloween, 1957, the Police Department received only a single complaint and that was a broken window. The children attending are awarded prizes of bicycles, dolls, sporting equipment, games, etc. and have moving pictures, ice cream, soda, candy, pastry and fruit. These parties have been sponsored for the past 12 years and have proven very successful.
