Be it ordained by the City of Providence:

SECTION 1. Chapter 1981-39, of the Ordinances of the
City of Providence, effective July 20, 1981, entitled: An
Ordinance Making an Appropriation of One Hundred Forty-Nine Million,
Eight Hundred Sixty-Two Thousand, One Hundred Twenty-Two Dollars
and Nine Cents (\$149,862,122.09) as amended, is hereby further
amended by transferring certain sums of money within the Depart-
