WHEREAS, Francisco Raymond Ogando was a well-known South Side business owner and community activist who lived in the Elmwood neighborhood; and

WHEREAS, Mr. Ogando was a pillar of the Dominican community in Rhode Island who helped countless immigrants and families adjust to life in America; and

WHEREAS, In recognition of his social, political, and cultural support for the Dominican community in Providence, Mr. Ogando was named Vice Consul of the Dominican Republic in the State of Rhode Island by presidential decree in 2004; and

WHEREAS, He was instrumental to the creation of a cultural exchange program between the Community College of Rhode Island and the Dominican Republic; and

WHEREAS, For many years, Mr. Ogando's tailor shop on the South Side of Providence was a popular informal community meeting space where people from all walks of life came to discuss everything from local community issues to worldwide current events; and

WHEREAS, Mr. Ogando passed away unexpectedly five years ago; and

WHEREAS, Renaming and rededicating Hancock Street as Ogando Street in honor of Francisco Raymond Ogando would be a fitting tribute to a remarkable individual who left an indelible imprint on our community.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of the Providence hereby renames Hancock Street as Ogando Street in honor of Francisco Raymond Ogando.

BE IT FURTHER RESOLVED, That upon passage, copies of this resolution be sent to the family of Mr. Ogando.
