


RESOLVED,

THAT the City Treasurer, acting under the direction of the Committee on Finance, be and hereby is authorized and directed to borrow from time to time, in such sums as may be necessary, not exceeding Eight Hundred Sixty Seven Thousand Seven Hundred Fifty (\$867,750) Dollars in accordance with the provisions of Title 45, Chapter 32, Section 42 and Title 45, Chapter 33, Sections 1, 2, 4 and 17 of the General Laws of Rhode Island 1956, entitled, "Redevelopment Act of 1956, and to issue the City's notes therefore, signed by him and countersigned by the Mayor and the Chairman of the Committee on Finance and to renew any such notes from time to time as the same become due. The money thus obtained shall be used exclusively for carrying out the Official Redevelopment Plan for the Silver Lake Revitalization Project.



Dear Mrs. Brassil:

I am writing in respect of the resolution regarding the borrowing of \$867,750.00 for the ~~Trinity Gateway~~ *Silver Lake* Revitalization Project.

I estimate the interest rate of a one year note at  $6\frac{1}{4}\%$  based on todays market conditions.

Accordingly, the interest cost on an annualized basis is estimated to be \$54,234.38.
