
Dear Councilwoman DiRuzzo:

This letter will serve to respond to your September 12, 1990 letter regarding the proposed resolution to name the newly developed street located off Woodward Road, "Amanda Court". Even though the proposed street name does not conflict with any other street name within the City of Providence, we have a concern with the name in our Delivery Area ZIP Code, 02904. This ZIP Code is divided between the City of Providence and the Town of North Providence. The Town of North Providence recently developed a new street and assigned the name Amanda Court. The assignment of an additional Amanda Court, even though it is in a different city/town, is sure to cause mail processing problems due to the fact that it is within the same Delivery Area ZIP Code.

Our recommendation to the committee is to change the suffix from court to any other approved suffix, examples being, road, drive, terrace, etc.

I would like to express my appreciation for your notifying the Postal Service of the proposed resolutions for the City, and I hope our input is of assistance to you and the City Council in making a decision. If it would be beneficial, we would be more than willing to sit down to discuss this or any other address issue with you or members of your committee.







SUBJECT: Changing Amanda Court to Amanda WAY

Mr. Johnson, per our phone conversation I am providing you with the information you requested. The Residents of Amanda Court in Providence off Woodward Rd. have been living there since June of 1990. This is a brand new build-up of five houses with five families living in them. The numbers to the five houses are 1, 3, 5, 7, 9. Not known to us at that time is the fact that in the same zip code is another Amanda Court. Needless to say this initially caused great hardship to all residents involved. P.S. - our builder and also our realtor should have been paying more attention to the potential for this thorn in the flesh situation.

I have been in constant contact with Mr. James Petrocinelli concerning this and he just recently gave me your name and phone. You were most gracious and courteous and advised me what our course of action should be.

Please note I have contacted my realestate lawyer Mr. Ronald C. Mankoff (Attorney At Law) and he advised me that it should not affect any legal papers that were signed if we change it from Amanda Court to Amanda Way of course the zip would still remain the same. Note - my lawyers Ph. # is 272-9330.

Last November Mr. Petrocinelli advised me that the City Council would not put a street sign up because of a letter sent by the Post Master General stating that something other than Amanda Court be disignated. You can check with Mr. Mike Clements (City Clerk) for a copy of that letter, "note" I do not have a copy. You can also check with Paula Jette (Quality of Service Representative) Post Office at 331-1230 on problems that had resulted from this situation.

Please consider this letter and the below signed signatures as a FORMAL REQUEST FOR ACTION about the change requested. When this is approved all five residents may need some kind of generic letter stating action taken because we may have to show our Mortgage Co.'s. I am also with the understanding that the position is still open for the person who would be stenciling in our new and only sign which should read AMANDA WAY. I (George B. 
