No. 352 **AN ORDINANCE** IN AMENDMENT OF AND IN ADDITION TO ARTICLE I OF CHAPTER 17 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE ENTITLED "OFFICERS AND EMPLOYEES", AS AMENDED.

Approved June 18, 1984

Be it ordained by the City of Providence:

SECTION I. Chapter 17 of the Code of Ordinances of the City of Providence entitled "Officers and Employees" is hereby amended by adding to Article I thereof the following:

"Section 17-31. Mailing of Paychecks. At least three times during each fiscal year of the City of Providence commencing with the fiscal year ending June 30, 1985 all employees and officers of the City of Providence shall receive their weekly paychecks by United States mail, proper postage prepaid, addressed to their respective residence addresses on file with the City of Providence. At least once each fiscal year of the City of Providence, all officers or employees of the City of Providence receiving pay on a monthly basis shall receive said paychecks by United States mail, proper postage prepaid, addressed to their respective residence addresses on file with the City of Providence.

2. The Finance Director shall select in his discretion the weekly or monthly paychecks to be provided to employees by United States mail without prior public notice to employees."

SECTION II. This ordinance shall take effect upon its passage.


