




Dear Mayor Smiley,

The Recovery Office respectfully requests approval to enter into a contract with the Rhode Island Public Health Institute to design a behavioral health screening protocol for Providence Recreation Centers and other trusted community settings in the amount of \$259,765.00 in Fiscal Year 2024.

The Department of Housing & Human Services, using ARPA funds, is seeking to develop a protocol for Behavioral Health screenings in Providence Recreation Centers and other trusted community settings. Designing this protocol requires a vendor with public health research and program design experience. The Rhode Island Public Health Institute's explicit purpose is to obtain and expedite competitive public health research, development, and projects.

In addition, the Rhode Island Public Health Institute is the sole vendor with these qualifications that is also a current Substance Abuse and Mental Health Services Administration grantee, in collaboration with the Rhode Island Department of Health and The Providence Center, to develop an integrated behavioral health program within their primary care clinic. The work done under this grant, which is taking place in their Providence-based clinic, creates a critical foundation for designing a similar protocol for Providence Recreation Centers and other community settings. The ability to build on this concurrent work results in significant savings for the City of Providence because the Rhode Island Public Health Institute can maximize its resources and apply relevant research, partnerships, capacity, and experience to this ARPA-funded project.

Funds in the amount of \$150,000.00 are available in account 263-1041-22; 53420 and \$109,765 are available in account ARPA 263-0044-22 in Fiscal Year 2024 and 2025.



Implementing community-based behavioral health programs in Providence, Rhode Island

Dear City of Providence,

Mental health illness is a major public health challenge in the United States, including in Rhode Island. Depression and anxiety among other mental health conditions disproportionately impact under resourced communities including African American/Black (AA/B) and Hispanic/Latino (H/L) individuals, as well as LGBTQ+ groups. Furthermore, mental health conditions have been exacerbated by the COVID-19 pandemic. Access to mental health care can be challenging. Barriers include limited behavioral health and clinical care programs focused on mental health, access to health care in general, stigma, and lack of awareness and education. The overall goal of the proposed project is to develop and implement a behavioral health screening and treatment program focused on providing services to underserved communities including AA/B, H/L and LGBTQ+ groups.

The proposed project will be led by the team at Rhode Island Public Health Institute (RIPHI) and Open Door Health (ODH). RIPHI is well positioned to take on this project, as ODH recently implemented an integrated behavioral health program which includes screening and behavioral health treatment for people with mental health illness. This program is funded by the federal Substance Abuse and Mental Health Service Administration, (SAMHSA), in collaboration with The Providence Center and the Rhode Island Department of Health.

Drawing on this new infrastructure, ODH will develop and help implement a screening and behavioral treatment program for residents of Providence, with a focus on Community Centers.
