ORDINANCES SECOND READING

The following Ordinances were in City
Council May 27, 1982 Read and Passed, the
First Time and Are Returned for Passage
the Second Time:

An Ordinance in Amendment of Chapter 4 by
Amending Section 4-34.1 which is Entitled:
"Proof of Ownership Required Prior to
Impounding Dog".

Be It Ordained By The City Of Providence:

Section 1. Chapter 4 of the Code of Ordinances
of the City of Providence is hereby amended by

amending Section 4-34.1, which shall read as
follows:

"Section 4-34.1. Proof of Ownership Required
Prior to Impounding Dog.

(A) Anyone attempting to commit or have
detained or impounded any dog or cat to a police
officer, dog officer or any other individuals
authorized by the city to exercise such control

must first sign an affidavit that he or she is the true owner of said animal.

(B) The dog officer shall charge a fee, as specified in the following schedule, to be paid by said owner of any dog or cat taken to the dog pound for the purpose of transferring title or for disposal according to law.

FEE SCHEDULE:

\$5.00 for each adult (6 months or older) dog
\$5.00 for each adult (6 months or older) cat
\$5.00 for each kitten or puppy."

Sec. 2. This Ordinance shall take effect upon its passage.

An Ordinance in Amendment of Chapter 4 by Amending Section 4-35 which is Entitled: "Redemption of Impounded Dogs or Other Animals".

Be It Ordained By The City Of Providence:

Section 1. Chapter 4 of the Code of Ordinances of the City of Providence is hereby amended by amending Section 4-35, which shall read as follows:

"Section 4-35. (a) The owner shall be entitled to regain possession of any impounded dog or other animal except as hereinafter provided in the cases of certain dogs, at any time upon the payment of impoundment fees set forth herein.

(b) Any dog or other animal impounded under the provisions of this article and not reclaimed by its owner within five (5) days, may be humanely destroyed by the dog officer, have its possession transferred to the Society for the Prevention of Cruelty to Animals as provided for in section 4-34(b), or placed in the custody of some person deemed to be a responsible person, who will agree

to comply with the provisions of this article and such other regulations as shall be fixed by the dog officer; provided, however, that such person pay to the dog officer an adoption fee of \$5.00."

Sec. 2. This Ordinance shall take effect upon its passage.

An Ordinance in Amendment of Section 16-3 of the Ordinances of the City of Providence Entitled: "Disorderly and Indecent Conduct", as Amended.

Be It Ordained By The City Of Providence:

Section 1. Section 16-3 of the Code of Ordinances of the City of Providence, entitled:

"Disorderly and indecent conduct," is hereby amended to read as follows:

Any person who engages in conduct which violates any of the following subsections thereby commits disorderly conduct:

(a) Any person who shall act in a threatening, violent or tumultuous manner toward another whereby any person is placed in fear of safety of his life, limb or health or the property of any person is placed in danger of being destroyed or damaged; or

(b) Any person who shall, in a public place or near a private residence that he has no right to occupy, disturb any person by making loud and unreasonable noise which under the circumstances would disturb a person of average sensibilities; or

(c) Any person who shall in a public place use "fighting words" or offensive language or words which by their very utterance inflict injury or are likely to provoke a violent reaction on the part of the average person so addressed; or

(d) Any person, who alone or in concert with others, obstructs any place ordinarily used for the passage of persons, vehicles or conveyances or otherwise engages in conduct which obstructs or interferes physically with a lawful meeting, procession or gathering; or

(e) Any person who shall assemble or congregate with another or others for the purpose of causing, provoking, or engaging or who shall cause, provoke or engage in any fight or other riotous conduct whereby the life, limb, health or property of another is endangered; or

(f) Any person who shall throw any stone or other missile upon or at any person, vehicle, building, tree, sign or other public or private property; or

(g) Any person who shall urinate or defecate on any public street, alley, sidewalk or floor of any public building or building where the public gathers or has access;

(h) Any person who enters upon the private property of another and looks into an occupied building structure located thereon without visible or lawful business with the owner or occupant thereof.

Any person who commits any of the aforesaid offenses shall be punished by a fine of not less than TWENTY-FIVE (\$25.00) DOLLARS nor more than TWO HUNDRED (\$200.00) DOLLARS or by imprisonment of not less than One (1) Day nor more than Thirty (30) Days or both such fine and such imprisonment.

If any clause, sentence, paragraph, section or part of this ordinance shall be adjudged by any court of competent jurisdiction to be invalid, such decree shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part directly involved in the controversy in which the decree shall have been

rendered. To this end, the provisions of this ordinance are severable.

Sec. 2. This ordinance shall take effect upon its final adoption.

Whereas, The United Way of Southeastern New

England is a community organization dedicated to improving the quality of life for area residents, and

Whereas, The United Way funds support several hundred human service programs covering needs in health services, recreational services, family services, educational services and counseling services, and

Whereas, More than 27,000 volunteers donate their time, effort and expertise to the United Way activities for determining community needs, raising funds and allocating monies on a priority basis of greatest need, and

Whereas, More than 500,000 members of this community use United Way services, and

Whereas, Current government funding has mandated more responsibility for the volunteer sector in meeting community human service needs,

Now, Therefore, Be It Resolved, That September 10, 1982 shall be proclaimed United Way Day in Providence and shall be celebrated with the public running of the Fifth Annual Great Race around Kennedy Plaza at 12:00 Noon, this race being an event that exemplifies the United Way Philosophy of "people helping people" through the use of human powered vehicles. Participants will put forth their human effort with pushed, pulled or pedalled vehicles to symbolize the effort needed for human need in this community.

COUNCILMAN PEARLMAN and COUNCILMAN FARMER (By Request):

Resolution Requesting the City Council to Consider the Providence Water Supply Board Budget as an Entity separate from the City Department's Budgets.

Whereas, Chapter 335 P.L. 1980 (approved 5/19/80), Section 39-1-2 General Laws of Rhode Island, 1956, was amended so as to specifically provide that the Providence Water Supply Board is a "public utility" within the meaning of that section, and

Whereas, The meaning of that section places the Providence Water Supply Board under the jurisdiction of the Rhode Island Public Utilities Commission, and

Whereas, The Providence Water Supply Board submitted a request to the Rhode Island Public Utilities Commission for an increase in the rate schedule to generate sufficient income to operate the system, and

Whereas, The Rhode Island Public Utilities Commission in its Report and Order of June 18, 1981 allowed an increase in the water rates sufficient to generate a total accrued revenue requirement of \$10,345,181, and

Whereas, The Rhode Island Public Utilities Commission has acted expeditiously in deciding on the request for a rate increase filed by the Providence Water Supply Board, and

Whereas, Given the Water Supply Board status as a public utility, it is within the authority of the Rhode Island Public Utilities Commission to define the financial relationship between the Water Supply Board and the City of Providence, and

Whereas, The Public Utilities Commission adheres to the view that and "arms length" relationship between the Water Supply Board

and the City of Providence "must be absolutely and scrupulously maintained", and

Whereas, The Public Utilities Commission has expressly conditioned the increase in rates in the Report and Order of June 18, 1981 on the establishment by the City of a "practice providing for independence and segregation of all revenues received by the Board", and "mandates that Board revenues and disbursements be separately accounted for through an 'enterprise fund' "

Now, Therefore, Be It Resolved, That the Providence Water Supply Board shall submit estimates of anticipated receipts and anticipated expenditures which shall be considered separately from the receipts and expenditures of the City of Providence General Fund and that financial transactions of the Providence Water Supply Board shall be conducted through an

"Enterprise Fund" with services provided by the City to the Water Supply Board properly accounted for and paid for by receipts from sales of water,

Be It Further Resolved, That the Providence Water Supply Board shall establish practices and procedures for operating that are consistent with the requirements of a regulated utility, with full cognizance for the responsibilities of the owner of the system, the City of Providence.
