RESOLVED, DECREED AND ORDERED:

That the following named street shown as cross-hatched on the accompanying plan entitled, Providence, R. I., Department of Public Works - Engineering Office, City Property Section, Plan No. 064332, dated September 24, 1985.

VIZ:

Reynolds Avenue (portion of) between Prairie Avenue and Gordon Avenue, shown as cross-hatched area on accompanying plan and designated by the letters (A-B-C-D-A) having ceased to be useful to the public and is proposed to be abandoned as a Public Highway, provided that the Narragansett Electric Company be conveyed an easement acceptable which will permit the retention of their facilities in existing locations in said Reynolds Avenue, together with the right to inspect, maintain, operate and replace same and further provided that the New England Telephone be conveyed an easement acceptable which will permit retention of its facilities in existing locations with the right to inspect, maintain, operate and replace same and with twenty-four hour access to said facilities, and the damage to the abutters is appraised at nothing, and so awarded, and it is further

ORDERED, That the Traffic Engineer be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further


ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the aboved-named highway which has been abandoned, who is known to reside within the State.

Dear Councilman Petrosinelli:

I represent Federated Lithographers-Printers, Inc. regarding a petition to condemn a section of Reynolds Avenue (between Prairie Avenue and Gordon Avenue) in South Providence. I would personally like to express our reasons for the condemnation request because our need and speed of acquisition is important to sustain our growth rate as a company in South Providence.

This Summer, we acquired the properties at 20 Gordon Avenue (formerly Apco Stationers), and the abandoned Oxford Press Building at 95 Reynolds Avenue. We are a growing printing company with need of additional manufacturing space.

We have been in contact with the Providence Department of Planning and Urban Development, and the City's Office of Economic Development. We have progressed to the point of the attached petition. I understand that your committee is currently handling our request.

I would like to request your assistance in expediting this street condemnation because we are using the Apco Building and require constant movement between both buildings. During the Summer, the weather has been in our favor, but with the Winter approaching, we need ownership of the street so as to connect both the building at 369 Prairie Avenue and the Apco Building in order to protect our employees and our product from the environment. We will start construction of the connector as soon as the City deeds the street to Federated.

It is my understanding that the Traffic Department has already submitted their report favoring the condemnation. Please contact me as to any hearing or if any further information is needed.

This department received a copy of a Petition for the abandonment of a portion of Reynolds Avenue Providence.


The depreciated reproduction value of the water main and service to be abandoned, plus the necessary work involved, is as follows:

It should be noted that the abandonment of the 6" Fire Service #26547 will be lost to the Providence Lithograph Company. This 6" Fire Service is in the building interconnected with the 6" Fire Service #26548 from Potters Avenue. The petitioner should be aware that loss of service from Reynolds Avenue may degrade his fire protection system.

We respectfully request that the petitioner be notified and that he agrees to pay the Water Supply Board the sum of \$3,383.39 before final action is taken by your committee.



Gentlemen:

The City Plan Commission at its September 18, 1985, re-scheduled regular monthly meeting reviewed and evaluated the subject referral from your Committee.

The petitioner is the Federated Lithographers - Printers, Inc.

A field inspection revealed that the portion of Reynolds Avenue proposed for abandonment is located between Prairie Avenue and Gordon Avenue. Reynolds Avenue is a local access street running along four blocks from Broad Street to its termination at Burnside Street. A field inspection revealed that the aforesaid portion of Reynolds Avenue is a paved public right-of-way 50' x 399'; traffic on aforesaid street is minimal. The surrounding land is used exclusively by light industry with some parking area. The aforesaid portion of Reynolds Avenue does not contain any public sewer lines. The nearest sewer lines are located under Gordon Avenue (30") and under Prairie Avenue (12"). The adjacent residential block surrounded by Reynolds Avenue, Gordon Avenue, Potters Avenue and Baxter Street is occupied by the newly renovated Barbara Jordan Apartments. The residential adjacent areas along Public Street and Prairie Avenue are in a process of extensive rehabilitation.


The portion of Reynolds Avenue proposed for abandonment contains a 6" cast-iron water line servicing adjacent properties. The Providence Water Supply Board informed us that they do not foresee any major problem in relocating this water line.

The proposed conceptual comprehensive plan for South Providence adopted existing light industrial uses along Reynolds Avenue with some possibility of their expansion on a land presently occupied by an automobile parking lot (Assessor's Lots 989, 976, 975, 959 and 578).

The Commission voted: to recommend to the Committee on Public Works that no objection is offered to this petition under the following conditions:

- that all adjacent properties would be under one ownership or all owners of adjacent properties agree to the proposed abandonment;
- that the cost of relocating the water line be borne by the petitioner.

This letter is in regards to our personal conversation concerning the Providence Journal news clipping of May 13, 1986 of Councilmember Lloyd Griffin and The Federated Lithographers controversy. As a property owner and life long resident of the South Providence Community I am very sympathetic to what the 10 Ward CouncilMember is trying to achieve for the people of this ward, however, while supporting his views of employment opportunities for South Providence residents, his desire to assist the firm in closing of the middle of Reynolds Avenue without notifying residents and property owners has me a little up tight. The topic of "trade offs" can sometime backfire, sometimes when compromise is taken, corruption is sooner not far behind, and we in the community know very well who are the loser in this. I wish to make my personal remarks because statements made in the article need to be clarified or better understood by community residents.

Both gentlemen, Mr. Bates and Councilmember Griffin are forgetting that they both are providing a service and that the service is successful because of people, citizens or consumers as we are called in 1986. My personal reason to inquire as to why residents and property owners located near and around the site in question were not advised concerning the closing of the Reynolds Avenue section. Why now has the company come out of its secrecy to boast of its accomplishments and financial awards and worth. The residents are of low income and unemployed and under employment conditions and to know that a business within their own community is prosperous is a slap in the face. I am personally knowledgeable of their hiring of minorities or the lack of their Equal Opportunity Program. As a community resident I was unemployed about three years 1982 - 1985 after the closing of The Outlet Department Store in the city and as their Shipping & Receiving Supervisor I found it very difficult to find a position outside of Providence, being a member of our minority community it became much more difficult, I have 20 years of experience within the field. I placed a personal resume with FLP but never heard from them, The company later had a position become available they placed an ad in the Providence Journal and I applied, was interviewed and given a tour of the company. Til this day I don't know if the position is still available or not. The Personnel Director was very impressed with my qualifications and the fact that I was a resident was just what the company wanted.

The purpose for writing this letter is twofold, first is to hope that my feelings and the feelings of resident property owners known. I am a trained Equal Opportunity Specialist, and as such, would like to see more community residents employed both from the Majority and Minority groups, as a Black man and less than equal provider in my home I would naturally like to see more Black people employed at this firm. With the possibilities of training within the community, the only excuse I can perceive is and would be labeled **RACISM**.

And finally, the matter of funding for the SPRC, I have to say that just isn't any thing I should concern myself with.

My second recommendation to Mr. Bates and Mr Griffin is, if closing off of the street is all that great and the business would suffer, I suggest that it be closed off during the firm's daily operations and left open at night and on the weekends. But, I am not a Councilmember or owner of a business, just a resident, citizen/property owner in the named community and like other things my voice don't mean a damn. I would like to make one more observation concerning the statement of Esq. McGinnis, his remarks of "QUOTA" borders on personal racism.



It should be noted that the abandonment of the 6" Fire Service #26547 will be lost to the Providence Lithograph Company. This 6" Fire Service is in the building interconnected with the 6" Fire Service #26548 from Potters Avenue. The petitioner should be aware that loss of service from Reynolds Avenue may degrade his fire protection system.

We respectfully request that the petitioner be notified and that he agrees to pay the Water Supply Board the sum of \$1,732.69 before final action is taken by your committee.

The City Plan Commission at its September 18, 1985, re-scheduled regular monthly meeting reviewed and evaluated the subject referral from your Committee.

The petitioner is the Federated Lithographers - Printers, Inc.

A field inspection revealed that the portion of Reynolds Avenue proposed for abandonment is located between Prairie Avenue and Gordon Avenue. Reynolds Avenue is a local access street running along four blocks from Broad Street to its termination at Burnside Street. A field inspection revealed that the aforesaid portion of Reynolds Avenue is a paved public right-of-way 50' x 399'; traffic on aforesaid street is minimal. The surrounding land is used exclusively by light industry with some parking area. The aforesaid portion of Reynolds Avenue does not contain any public sewer lines. The nearest sewer lines are located under Gordon Avenue (30") and under Prairie Avenue (12"). The adjacent residential block surrounded by Reynolds Avenue, Gordon Avenue, Potters Avenue and Baxter Street is occupied by the newly renovated Barbara Jordan Apartments. The residential adjacent areas along Public Street and Prairie Avenue are in a process of extensive rehabilitation.


The portion of Reynolds Avenue proposed for abandonment contains a 6" cast-iron water line servicing adjacent properties. The Providence Water Supply Board informed us that they do not foresee any major problem in relocating this water line.

The proposed conceptual comprehensive plan for South Providence adopted existing light industrial uses along Reynolds Avenue with some possibility of their expansion on a land presently occupied by an automobile parking lot (Assessor's Lots 989, 976, 975, 959 and 578).

The Commission voted: to recommend to the Committee on Public Works that no objection is offered to this petition under the following conditions:

- that all adjacent properties would be under one ownership or all owners of adjacent properties agree to the proposed abandonment;
- that the cost of relocating the water line be borne by the petitioner.
