
COUNCIL PRESIDENT EASTON calls for nominations for Public Administrator for the term 1987 - 1989.



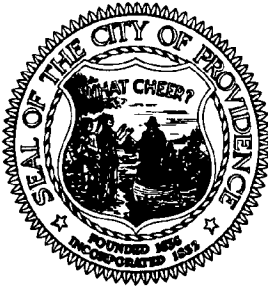
