



ANNUAL REPORT OF THE ACTIVITIES OF THE ZONING BOARD OF REVIEW  
AND THE ZONING OFFICE FOR THE CALENDAR YEAR 1967

During the year 1967 the Zoning Board of Review held fourteen meetings which were public hearings on applications for exceptions or variances, and a corresponding number of executive sessions. For the year 1967, the Board acted on 99 applications of which 71 were granted, 16 were denied, 4 requested leave to withdraw and 4 were continued for further study. Eight extensions were requested, all were granted. Five requests to file successive petitions were acted upon, all were granted.

Three decisions of the Board were appealed to the R. I. Supreme Court. Four cases were disposed of by the Supreme Court; the Board was overruled on three, and one was allowed to withdraw by stipulation. Five cases concerning the Zoning Board of Review are still pending in the Supreme Court as a result of appeals of 1967 and previous years.

The following Board activity took place: Mayor Joseph A. Doorley, Jr. reappointed William A. Greene, January 2, 1967 for a term ending the first Monday in June 1971; and, reappointed Harry J. Licht, May 31, 1967 for a term ending the first Monday in June 1972.

Zoning plat maps were updated, and Supreme Court cases pertaining to the Zoning Board were catalogued. A continuing study of the proposed new Zoning Ordinance and the proposed new Zoning map was initiated.

During the year 1967, the Building Board of Review held ten public hearings and disposed of forty-nine applications for variances or modifications of the Building Ordinance. Forty-five of these petitions were granted as filed, twenty granted with provisions, and there were two denied. Two of these petitions were granted permission to withdraw.

Mayor Joseph A. Doorley reappointed Henry Turoff on January 2, 1967 for a term ending March 31, 1971 and on December 13, 1967 the Mayor appointed James J. O'Rourke, Electrical Contractor for the balance of the term of Thomas F. Kearney, resigned, ending March 31, 1968.

During the year of 1967 the Housing Board of Review held six meetings, five of which were public hearings on appeals for exceptions under the Housing Ordinance and one executive meeting.

During the year the Board acted on eight appeals and two cases continued from 1966. Six were granted relief, two were partial grants and partial denials. One was denied and one was discontinued.

Currently being continued are four appeals that the Board could not decide until final determination of the location of the Route 6 Downtown Connector. This condemnation took place in late Dec. 1967 and the cases will be reviewed in early 1968.

Mayor Joseph A. Doorloy Jr., reappointed Joseph P. Flynn, member and chairman on April 31, 1967 to a term ending June, 1972. Dr. Louis Bruno continued to serve on the Board.
