Attached please find a real estate bill for Helen W. Walsh who resides at 82 Dana Street, Providence.

I would like to submit a Resolution to be presented at the next City Council meeting on February 1, 1990 to relieve these taxes which have accumulated since 1985.

A brief explanation of this situation I feel is appropriate. I have been working with Mrs. Walsh for approximately five years now in regard to her back due property taxes and other financial need situations.

1. Mrs. Walsh should have applied for indigent status in 1984 and 1985.
2. She filed for indigent status in 1987 under my direction and was granted an adjustment.
3. Because of a communication problem and deaths in her immediate family she failed to file for years 1988 and 1989.

Mrs. Walsh can not afford this expenditure and has exhausted all other avenues to clear this bill. Her home at this time is in jeopardy of tax sale as it has been in the past. If there is any further need for information in this matter, please feel free to contact me at any time.
