ORDINANCES SECOND READING

The Following Ordinances were in City Council May 15, 1980, Read and Passed the First Time and Are Returned for Passage the Second Time:

An Ordinance Authorizing the City Council of the City of Providence, Rhode Island, to File An Application for the Funding under the Housing and Community Development Act of 1974, for Funds for the Community Development Block Grant Entitlement Funds for the Fiscal Year, 1981.

Be It Ordained by the City of Providence:

Whereas, The City of Providence is eligible to receive Community Development Block Entitlement Funds for the fiscal year, 1981 under Section 106(a) or (h) of Title I of the Housing and Community Development Act of 1974, (Public Laws 93-383; and

Whereas, The said Application for Funding shall be filed with the Department of Housing and Urban Development, not later than April 15, 1980.

Section 1. The City Council of the City of Providence, County of Providence, State of Rhode Island, hereby authorized the City of Providence, through its official representative, the Mayor, to file an application for Community Development Block Grant Entitlement Funds for the fiscal year, 1981, under Section 106(a) or (h) of Title I of the Housing and Community Development Act of 1974, (Public Laws 93-383) to do all acts necessary to successfully acquire said funds.

Section 2. All monies received by the City of Providence from the federal government under the provisions of Section 106(a) or (h) of Title I of the Housing and Community Development Act of 1974, (Public Laws 93-383), shall be expended in accordance with the provisions of said Act and shall be by Ordinance of the City Council. The

Citizens Review Board may comment on the plan for expenditure of funds so received. The City Council will consider the views of the Citizens Review Board but it shall retain to itself the final approval for the expenditure of funds. No funds received under said Act shall be allocated for specific projects nor expended without the approval of the City Council.

Section 3. The Mayor and City Council may require any and all information relative to the expenditure of Community Development Act Funds and at any time conduct investigations pursuant to the existing provisions of the City Charter, and shall require that all employees of the said program shall be qualified electors and residents in the City of Providence, Rhode Island.

Section 4. Upon the written request of the City Council of the City of Providence, Rhode Island, names, addresses and salaries of all personnel engaged in this program shall be submitted to the said Council.

Section 5. There shall be submitted to the City Council and the Citizens Review Board by the Finance Director of the Community Development Act, on a monthly basis a line item budget showing (a) Project Account, (b) Amount Budgeted, (c) Amount Expended, (d) Balance.

Section 6. The Mayor shall submit to the City Council and the Citizens Review Board on a Quarterly basis a narrative progress report on each program including supporting data.

Section 7. The Mayor shall be responsible for negotiating all contracts with outside agencies subject to approval by Ordinance of the City Council.

Section 8. Amendments to the Community Development Program during the program year necessitating the reallocation of funds or the designation of new activities shall be subject to at least one Public Hearing, review by the Citizens Review Board and final approval by Ordinance of the City Council.

Section 9. This Ordinance shall take effect upon its passage by the City Council.

An Ordinance in Amendment of and in Addition to Article IV, Section 13-100 of the Code of Ordinances of the City of Providence Entitled: "Liens and Charges for Expenses of Director".

Be It Ordained by the City of Providence:

Section 1. Article IV, Section 13-100 of the Code of Ordinances of the City of Providence, entitled "Liens and charges for expenses of director" is hereby amended and added to as follows:

Whenever the owner fails to comply with an order to repair, alter or improve, or to demolish a dwelling or structure which has been determined to be unfit for human habitation and continued occupancy and the director has taken direct action pursuant to the provisions of Section 13-98 or 13-99 of this Chapter, the costs incurred by him in such action together with a ten percent (10%) service charge in addition thereto, shall be a lien against all the real property owned by that person or corporation within the City of Providence, provided however that such lien shall be enforced in the manner provided or authorized by law for the enforcement of common law liens on personal property. Such lien shall be recorded with the records of land evidence of the City of Providence and the lien shall incur legal interest from the date of recording.

Section 2. This Ordinance shall take effect upon its passage.

An Ordinance in Amendment of and In Addition to Article I of the Code of Ordinances of the City of Providence, by Adding Section 5.4, to be entitled: "Protection of Lots".

Be It Ordained by the City of Providence:

Section 1. Article I of the Code of Ordinances of the City of Providence is hereby amended by adding Section 5.4, which shall read as follows:

"Section 5.4 Protection of Lots.

Whenever application is made for a permit to demolish a structure the Building Inspector shall require that application also be made and that plans be submitted and carried out within sixty (60) days of said application or whenever seasonable conditions may allow, for the protection of said lot by grading and seeding; application of concrete, gravel, asphalt, or other suitable refinishing material; or the rebuilding on said lot. The Building Inspector may further provide in his discretion, for the fencing of said lot if he believes it necessary for the prevention of said lot from becoming a harborage or dumping ground."

Section 2. This Ordinance shall take effect upon its passage.

An Ordinance Amending Article VI of the Code of Ordinances of the City of Providence by Adding Section 2.99.1, to be Entitled: "Division of Housing and Buildings".

Be It Ordained by the City of Providence:

Section 1. Article VI of the Code of Ordinances of the City of Providence entitled "City Solicitor" is hereby amended by adding Section 2.99.1 as follows:

"Section 2.99.1 Division of Housing and Buildings.

The City Solicitor shall appoint in the month of July, 1980 and thereafter as such vacancy shall occur, a Deputy City Solicitor for housing and buildings whose duty it shall be to prosecute all cases referred to his Department by the Director of Minimum Housing, the Building Inspector, or the Director of Environmental Control.

The Deputy City Solicitor for housing and buildings shall appoint Two (2) Assistant City Solicitors, Two (2) Paralegals and Two (2) Secretaries and such other staff as the Council shall by Ordinance provide and the Deputy City Solicitor, One (1) Assistant City Solicitor, One (1) Paralegal and One (1) Secretary, shall work in the Division of Code Enforcement and receive day to day direction and assignments from the Chief of Code Enforcement. The other Assistant City Solicitor, Paralegal and Secretary shall work in the Department of Building Inspection and shall receive day to day direction and assignments from the Building Inspector.

In no event shall any of the staff be removed from the assigned location or assigned any duties outside of their given department or division except when necessary in the opinion of the aforementioned deputy, staff may be moved between the Division of Code Enforcement and the Building Inspector's Office for a limited period of time with the approval of the Chief of Code Enforcement and the Building Inspector.

All of the positions called for in this Ordinance shall be full time positions.

The Finance Director in preparing the budget for fiscal year 1980-1981, and each year thereafter, shall make provisions for the salaries of each of the above individuals and reasonable expenses necessary for the operation of the Division of Housing and Buildings."

Section 2. This Ordinance shall take effect upon its passage.

An Ordinance in Amendment of and in Addition to Chapter 27 of the Code of Ordinances of the City of Providence by Adding Section 27-3 to be entitled: "Correcting Violations Prior to Exceptions".

Be It Ordained by the City of Providence:

Section 1. Chapter 27 of the Code of Ordinances of the City of Providence is hereby amended by adding Section 27-3, which shall read as follows:

"Section 27-3. Correcting Violations Prior to Exceptions.

No petition to the Zoning Board of Review shall be granted whenever the owner of such property has currently on file with the Recorder of Deeds, a notice of violation on any property owned by such person or corporation in the City of Providence unless he shall include plans for correction of all such violations."

Section 2. This Ordinance shall take effect upon its passage.

An Ordinance in Amendment of and in Addition to Article I of the Code of Ordinances of the City of Providence by Adding Section 5.5 to be entitled: "Correcting Violations Prior to Exceptions".

Be It Ordained by the City of Providence:

Section 1. Article I of the Code of Ordinances of the City of Providence is hereby amended by adding Section 5.5, which shall read as follows:

"Section 5.5 Correcting Violations Prior to Exceptions.

No petition to the building board of review shall be granted whenever the owner of such property has currently on file with the recorder of

deeds a notice of violation on any property owned by such person or corporation in the City of Providence unless he shall include plans for correction of all such violations".

Section 2. This Ordinance shall take effect upon its passage.
