ELECTION OF COUNCILMANIC MEMBERS OF CITY PLAN COMMISSION

COUNCIL PRESIDENT HAXTON calls for nominations for two Members of the City Council to serve on the City Plan Commission and COUNCILMAN LYNCH nominates COUNCILMAN LOUIS A. MASCIA; this nomination is seconded by COUNCILMEN LORENZO and SCIARRETTA.

COUNCILMAN ADDISON nominates COUNCILMAN MICHAEL E. KELLY; this nomination is seconded by COUNCILMAN JOHNSON.

COUNCIL PRESIDENT HAXTON calls for further nominations and there are none.

There being no further nominations, on motion of COUNCILMAN SCIARRETTA, seconded by COUNCILMAN LYNCH, it is voted that nominations be closed and the Clerk be directed to cast one ballot for COUNCILMAN MASCIA and for COUNCILMAN KELLY as Councilmanic Members of the City Plan Commission.

The Clerk casts one ballot for COUNCILMAN MASCIA and for COUNCILMAN KELLY, as directed.

COUNCIL PRESIDENT HAXTON thereupon declares COUNCILMAN LOUIS A. MASCIA and COUNCILMAN MICHAEL E. KELLY duly elected as Councilmanic Members of the City Plan Commission for the ensuing terms ending on the First Monday in January, 1975.
