Establishing the Classes of Position, the Maximum Number of Employees and the Number of Employees in Certain Classes in the Water Supply Board and Repealing Ordinance Chapter 1993-37, Approved October 29, 1993

Approved November 23, 1994

Be it ordained by the City of Providence:
