RESOLVED, DECREED AND ORDERED:

That the following portion of named street as shown as cross-hatched area on the accompanying Plan entitled, "Providence, R.I., P.W. Dept. - Engineering Office, Street Line Section, Plan No. 063800, dated October 31, 1973",

viz:


Portion of East George Street in the City of Providence from on the range of the westerly line of Butler Avenue to a point square opposite the easterly line of lot 415 as set out and delineated on City Assessor's Plat 15, having ceased to be useful to the public and the same is proposed to be abandoned as a public highway; subject to full sewer easement required by the Department of Public Works incorporated on Plan No. 063800, and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, that the Director of Public Works, be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, that after the entry of this order or decree, the City Clerk shall cause a notice, thereof, to be published in a newspaper published in the County of Providence as least once a week for three successive weeks, and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.






On August 9, 1977 this department received copies of petitions for the abandonment of portions of the following streets:
