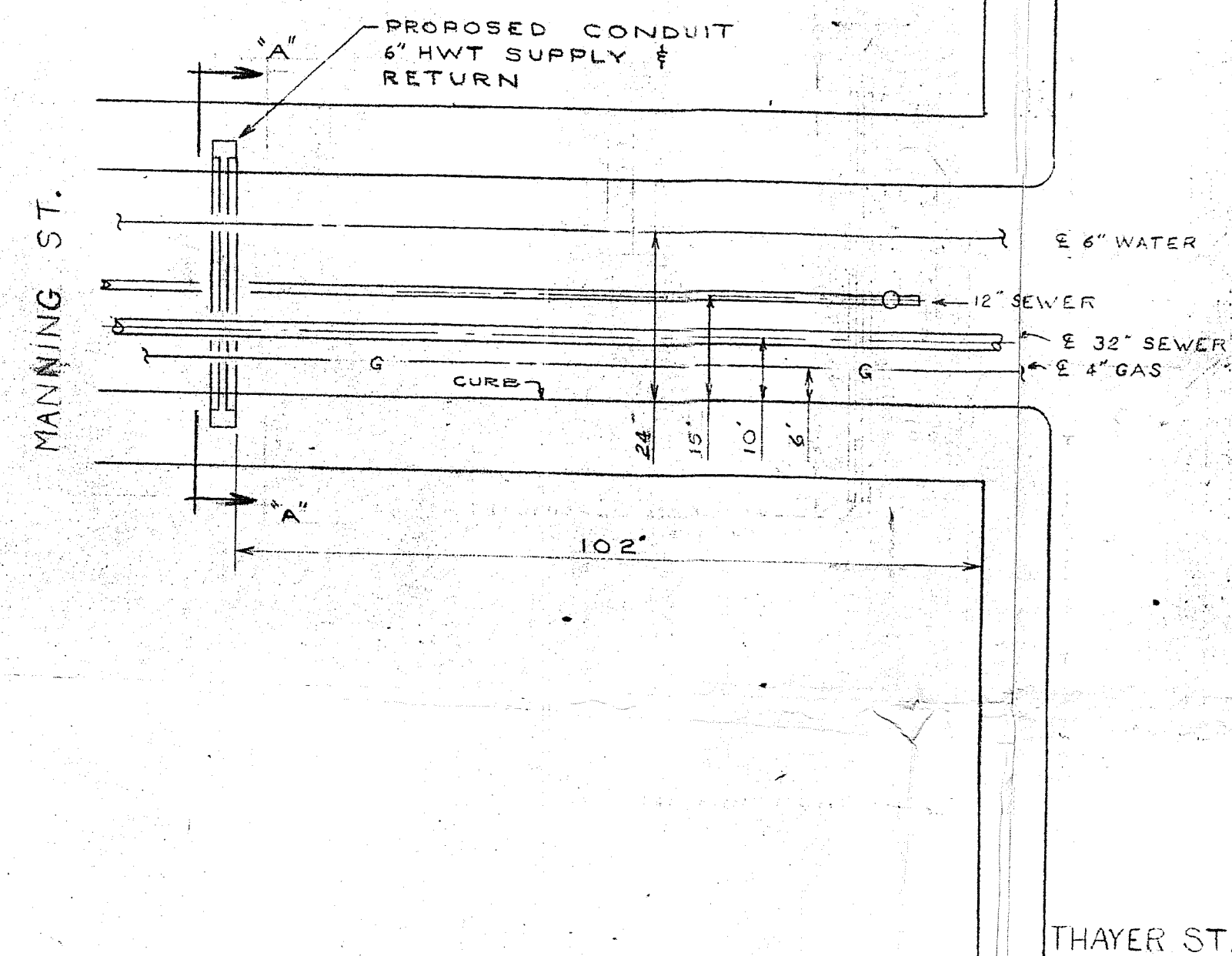

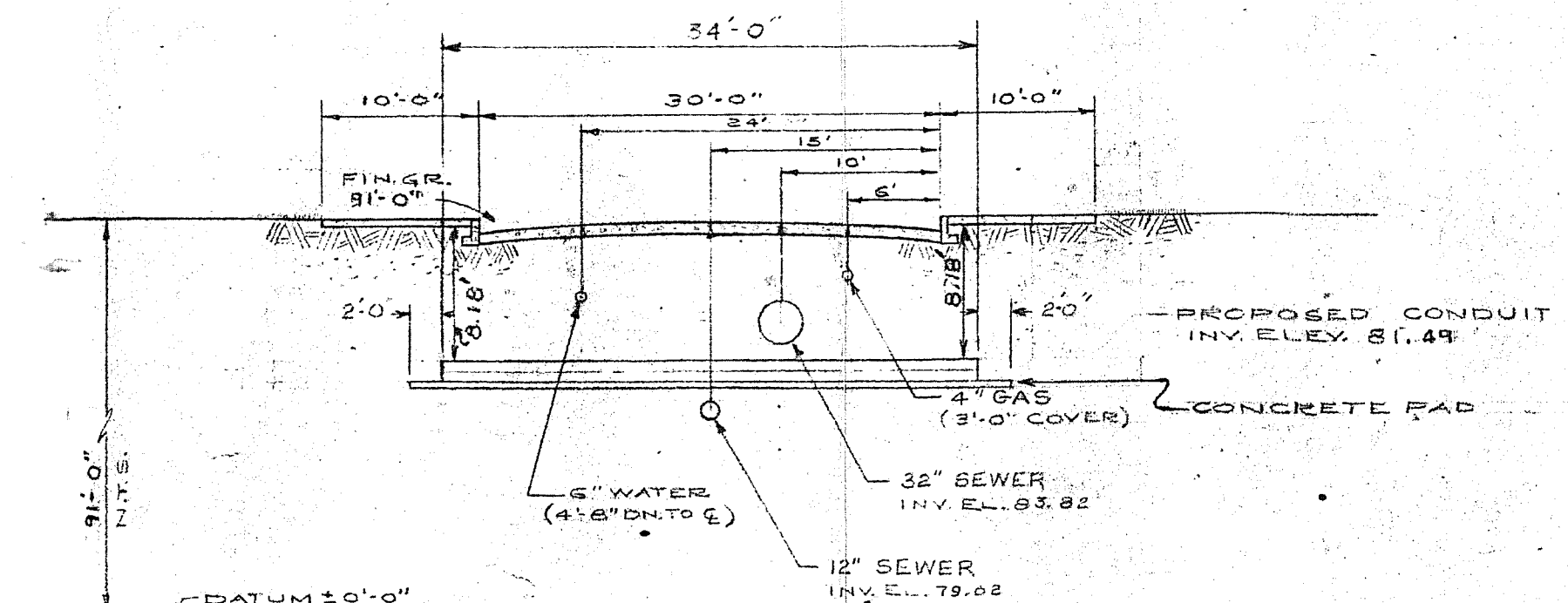

CITY OF PROVIDENCE, R.I.

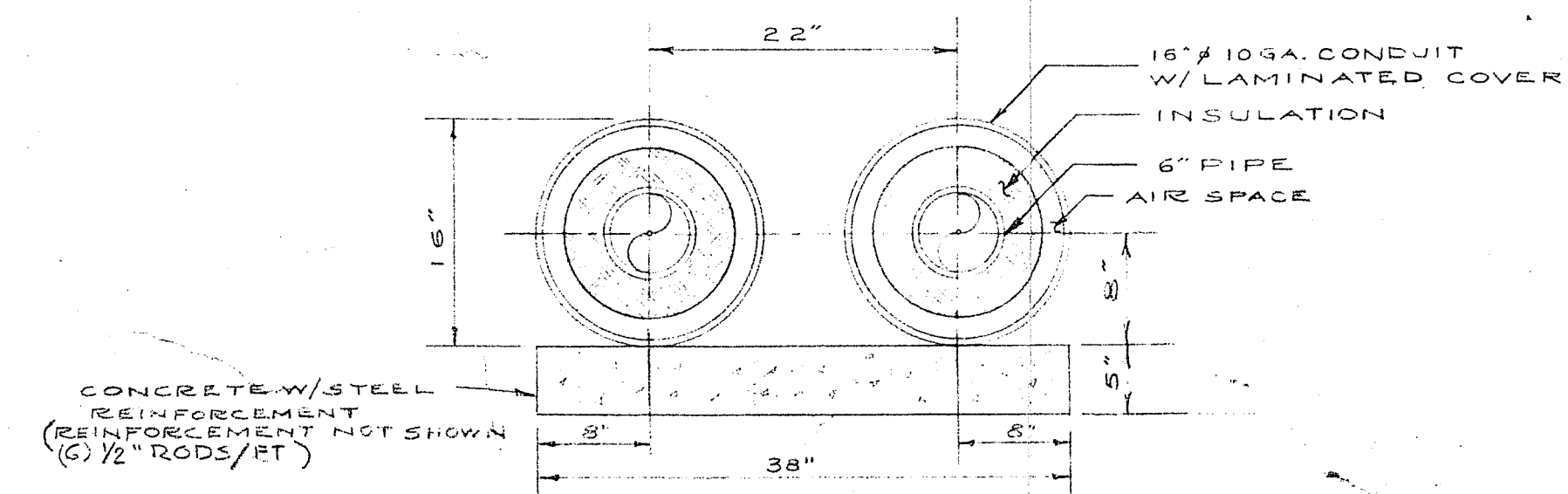
