PRESENTATION OF RESOLUTIONS

COUNCIL PRESIDENT LOMBARDI (By Request):

Resolution in support of the Town of Barrington proclaiming April 2000 as "Alcohol Awareness Month".

Whereas, Alcohol involvement is the single greatest factor in motor vehicle deaths and injuries, and though only four percent of all crashes involve the use of alcohol, alcohol contributes to forty one percent of fatal crashes, and

Whereas, Approximately one million people are injured annually in alcohol related traffic accidents; and

Whereas, At .08 everyone is impaired to the point that critical driving skills such as reaction time, attention, tracking and comprehension are degraded; and

Whereas, Many states are now lowering the BAC defining impaired driving from .10 to .08; a BAC as low as .02 has been shown to affect driving ability and crash likelihood; and

Whereas, If every state adopted a .08 per se law, between 500 and 600 lives could be saved every year according to a recent study conducted by researchers at Boston University; and

Whereas, A .08 law serves as a general deterrent to drinking and driving, sends a message that the state is getting tougher on impaired driving and makes people think twice about getting behind the wheel after they've had too much to drink.

Now, therefore, be it Resolved, That the City Council of the City of Providence does hereby proclaim April 2000 is Alcohol Awareness Month in the City of Providence and requests that Providence's legislative delegation vote in favor of the .08 legislation in their capacities in the General Assembly.

Resolution Requesting the City Council to establish a Mosquito Abatement District and Council.

Whereas, In accordance with Rhode Island General Laws Sections 23-7-7 "Establishment of Mosquito Abatement Districts and Local Councils", only those cities or towns formally established as mosquito abatement districts may conduct programs of mosquito control. Steps for formal establishment are as follows:

(1) Form a Mosquito Abatement District Council consisting of at least three individuals:

(a) The Chief Executive or Administrative Head of the City.

(b) The City Council President or some other designee.

(c) A third elected or appointed official designated by the first two members. In most cases, this person will be the Mosquito Control Program Director.

(2) Give Public Notice and allow Public Hearing of the proposed mosquito abatement program. A publicly posted agenda of the City Council or Financial Meeting at which the program is considered will satisfy this requirement.

(3) Notify the Rhode Island Mosquito Abatement Board through the Department of Environmental Management Mosquito Abatement Coordinator, Government Center, Tower Hill Road, Wakefield, Rhode Island 02879, that the district has been formed, giving a description of district boundaries and list of district Mosquito Abatement Council Members.

(4) File Notice of the formation and boundaries of the proposed district with the Secretary of State, State House, Providence, Rhode Island 02903. In most cases, boundaries of the district will be the geographical limits of the town or city. Boundaries may also be the jurisdictional limits of a fire district or the geographical limits of contiguous cities, towns or subdivisions.

Now, therefore, be it Resolved, That the Members of the Providence City Council hereby request to establish a Mosquito Abatement District and Council.

COUNCIL PRESIDENT LOMBARDI:

Resolution Requesting the Providence School Department to adopt stricter state standards in its classroom practices (1997 Education law known as Article 31).

Whereas, Article 31 was intended to motivate schools statewide to do a better job teaching and push students to reach higher academic standards, and to hold schools accountable if they don't deliver results, and

Whereas, Several board members, officials from the state Department of Education and state legislators who toured the local schools referred to Coventry as "a cutting-edge district"

with a lot of ideas to offer other communities, and

Whereas, Coventry was the first district the Board of Regents visited to see the law in action, because it's one of the only districts in the state that has started to achieve the legislation's goals. It appears that Coventry is at the forefront of many education initiatives, especially with the standards movement, they're bearing results, and

Whereas, The presentation about the school's new style of teacher conferences, which involve both students and parents. The state officials praised the schools for posting the math and language arts standards on the walls and displaying examples of exceptional student work. They also noted the level of professionalism among the faculty members, and

Whereas, The district's scores on the statewide New Standards Reference Exams in math and language arts, which all fourth, eighth and tenth graders take each year, have improved over the last couple of years, and

Whereas, Not all of the students are proficient yet, and the district has developed "safety-net programs," such as before-and after-school tutoring sessions to help them improve. We realize that there are still kids struggling with this model. Indeed, Coventry isn't perfect but it could be as good as it gets in terms of making Article 31 a reality. The district offers the regents a great example of the education legislation's success.

Now, therefore, be it Resolved, That the Providence City Council hereby requests the Providence School Department to adopt stricter state standards in its classroom practices (1997 Education law known as Article 31).

Resolution Requesting the Providence School Department to adopt the American Federation of Teachers proposal for a national test and rigorous new standards for those who want to become teachers.

Whereas, Preempting a growing national movement to impose tougher standards on teachers, the American Federation of Teachers, the nation's second-largest teachers union, will propose a national test and rigorous new standards for those who want to become teachers, and

Whereas, The proposal, a departure from traditional union opposition to increased teacher testing, comes amid heightened worries from educators, parents and politicians about the declining quality of the nation's teaching force and those entering it, and

Whereas, About a third of all teachers lack a major or minor in subjects they teach, meaning that about four million children every year learn math from someone who may not have taken a math class since high school. While most states have teacher tests, most require only the equivalent of a high school education to pass, in part because unions have blocked efforts to set the bar higher, and

Whereas, Some two million teachers are due to be hired or replaced nationwide over the next decade, with many states struggling to find enough qualified people to lead their classrooms, and

Whereas, The union said it wanted to take advantage of that opportunity and was making its recommendations after two years of studying teacher preparation programs. The proposal would not affect current members, and

Whereas, Unions have long said that tests are a poor measure of the gifts that make a good teacher. But ultimately, tests and tougher standards can give the teaching profession the same rigor, and the same status, that board and bar exams give doctors and lawyers. With schools in almost every state subjecting students to tougher tests, it only makes sense to demand the same of teachers, and

Whereas, While the union proposal comes late to the bid for better teachers, it also adds a crucial voice to the lawmakers and parents who have called for reforms. Any attempt to adopt such a national program will be bucking a long tradition of strong local control over education, and

Whereas, Rhode Island does give teachers a certification exam, but because of an amendment passed by the General Assembly in 1991, teachers who fail it can teach anyway. The union argues that teachers should pass a competency test if they expect to be treated like professionals, and

Whereas, Under the 1991 amendment, any teacher who fails the exam undergoes an annual job evaluation by the local school district for three years. However, that teacher does not have to pass the exam at the end of three years, and

Whereas, The amendment, sponsored by former State Representative Harold Metts, of Providence, was designed to ensure that minorities were not excluded from the teaching profession because of language or cultural barriers. At the time, leaders of the minority community charged that the National Teacher Exam discriminated against minorities because some of the questions required cultural knowledge that had nothing to do with mastery of a specific subject, and

Whereas, A recent survey by the State Department of Education showed that during the 1998-99 school year, 90 teachers out of approximately 8,500 statewide had not passed the exam.

Now, therefore, be it Resolved, That the Providence City Council do hereby support the American Federation of Teachers proposal for a national test and rigorous new standards for those who want to become teachers.

I am aware of Providence's residency rule and have received a layoff letter explaining that my teaching contract will end on the last day of 1999-2000 school year. I am requesting an extension that will allow my employment to continue to June 30, 2000.

My rationale for this request is multi-faceted. The primary reason in requesting an extension is to maintain the educational flow of my students without interruption. As you know this multicultural student population or any other, needs consistency to best serve them in their learning progress. Also since my wife, who is

an assistant principal, has been "grandfathered in" and therefore, is not required to move into the city, it seems unreasonable for me to entertain this option **at least for now**. Another reason is that relocation at this time would cause an interruption in our own children's schooling as we may be forced to remove them from their school setting and transfer them into Providence. The final reason is that during my search for comparable housing in Providence, I noticed that the costs for relocation would present an undue financial burden on my family. **Please be assured that I will continue to pursue sufficient housing in Providence in anticipation for the next school year in order to best serve the children.**
