RESPONSE:

Please be advised that the intersection of Knight Street and Atwells Avenue is scheduled for the installation of a flashing pedestrian warning beacon at a cost to the City of Providence of \$8,800.00. The installation is awaiting the delivery of a special steel pole and mast arm to the contractor. This should be installed within four weeks.

The intersection of Atwells Avenue and Sutton Street is presently under review to determine if this intersection meets the warrants as set forth in the Manual on Uniform Traffic Control Devices. As you can see, the cost for such an installation is very high and we do not have the monies available for any new installation this fiscal year. In our 1987-1988 Budget requests, we will be requesting funds for the installation of fully-actuated traffic signal systems as well as for flashing warning signal beacons. As soon as we know what funds will be allocated, we will prioritize those intersections that have been requested by the City Council and private citizens as well as those that I have surveyed for needed signalization. In the meantime, we will determine if additional warning signs and traffic controls can be installed at the intersection of Atwells Avenue and Sutton Street.
