No. 274 AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE,
CHAPTER 1143, BY APPROPRIATING THE SUM OF THIRTY FIVE HUNDRED
(\$3500) DOLLARS TO TRAFFIC ENGINEERING DEPARTMENT, ITEM 1.

Approved May 16, 1958

Be it ordained by the City of Providence:

SECTION 1: Chapter 1143 of the Ordinance of the City of Providence,
as approved September 20, 1957, entitled: "An Ordinance Making Appropriation of
\$36,161,545.40 for the Support of the City Government for the Fiscal Year Ending
September 30, 1958", as amended, is hereby further amended by appropriating the sum
of Thirty Five Hundred (\$3500) Dollars to TRAFFIC ENGINEERING DEPARTMENT, ITEM 1.

SECTION 2: The said sum of Thirty Five Hundred (\$3500) Dollars as
thus added and appropriated shall be obtained by authorizing and directing the City
Controller and the City Treasurer to transfer a like amount from the Reserve for
Extraordinary Expenditures to the Receipt Account.

SECTION 3: The estimated receipts from the Reserve for Extraordinary
Expenditures are hereby increased by Thirty Five Hundred (\$3500) Dollars.

SECTION 4: This Ordinance shall take effect upon its passage.

Resolved,

That permission is hereby granted The Narragansett Electric Company, a duly organized and existing corporation of the State of Rhode Island, having been created by Special Act of the General Assembly of said State, passed at its January Session, A. D. 1926, and a public utility as defined in Section 39-1-2 of the General Laws of 1956, and authorized and empowered, among other things, to engage in the production, transmission, delivery and furnishing of electricity for light, heat and power, in accordance with the provisions of Chapter 1418 of the Public Laws of 1916 and in accordance with plans heretofore approved by the Director of the Department of Public Works to construct, install, maintain, operate, repair, replace and inspect a pipe line, together with all necessary insulation, casings, fixtures, supports, attachments and appurtenances, for transmission and conveyance of steam between the Manchester Street and the South Street generating stations of The Narragansett Electric Company, in the City of Providence, under and across Point Street, in said City, and to attach said pipe line, and as the same may be reconstructed, repaired or replaced, to the fixed portion of the westerly end of the Point Street Bridge structure, all to be in conformity with approved and accepted standards for this type of construction and to be substantially as shown on that plan accompanying the Petition of The Narragansett Electric Company, dated April 30, 1958, and entitled "PROPOSED STEAM LINE AT POINT STREET BRIDGE IN PROVIDENCE RIVER AT PROVIDENCE, RHODE ISLAND APPLICATION OF THE NARRAGANSETT ELECTRIC COMPANY APRIL 28, 1958".

The permission hereby granted is upon the condition that said pipe line shall be so constructed and installed as not to interfere with the use of said Point Street or said Point Street Bridge by the public; and upon the condition that said pipe line shall be

constructed in accordance with plans approved by the Director of Public Works of said City of Providence and under his supervision and control and to his satisfaction; and upon the condition that said pipe line shall be removed upon ninety (90) days previous notice from the City Council whenever in the opinion of said City Council the public interest may require its removal; and upon the condition that in case said City of Providence shall at any time hereafter be authorized to assess abutting owners for the private use and occupation of the public highways the passage of this resolution shall not in any manner effect the right of the City to charge and collect rent for the use of said Point Street by reason of construction and installation of said pipe line; and upon the condition that The Narragansett Electric Company, its successors and assigns, shall hold and keep said City of Providence harmless, safe and indemnified from and against loss, cost, damage, payment and expense on account of any injuries to persons or damage to property for which said City may become liable on account of the construction, installation, maintenance, operation, repair, replacement or inspection of, or any defect in said pipe line under and across said Point Street, or neglect properly to maintain or repair any of the aforesaid, unless the wrongful act or negligence of the said City of Providence, its officers or employees, shall cause such injury or damage as is mentioned aforesaid; and upon the condition that The Narragansett Electric Company before commencing the work of constructing and installing said pipe line under and across said Point Street shall file its bond in the sum of Twenty-five Thousand Dollars (\$25,000) in form satisfactory to the City Solicitor to hold and keep said City harmless, safe and indemnified as aforesaid; and it is agreed by the acceptance hereof that the amount of said bond shall not be construed or held to limit the general obligation of The Narragansett Electric Company to hold and keep said City harmless, safe and indemnified as aforesaid; and upon the further condition

that The Narragansett Electric Company shall, before commencing the work of constructing and installing said pipe line under and across said Point Street, file with the City Clerk its written acceptance of the terms and conditions of this Resolution and its agreement to perform and observe all of the terms and conditions hereof.

PETITION OF THE NARRAGANSETT ELECTRIC COMPANY FOR
PERMISSION TO BUILD AND MAINTAIN A PIPE LINE
BETWEEN ITS ESTATES LOCATED ON THE NORTHERLY AND
SOUTHERLY SIDES OF POINT STREET.

TO THE HONORABLE, THE CITY COUNCIL OF THE CITY OF PROVIDENCE:

Your Petitioner, The Narragansett Electric Company, respectfully represents:

1. That your Petitioner is a duly organized and existing corporation of the State of Rhode Island, having been created by Special Act of the General Assembly of said State, passed at its January Session A.D. 1926; is a public utility as defined in Section 39-1-2 of the General Laws of 1956; and is authorized and empowered, among other things, to engage in the production, transmission, delivery and furnishing of electricity for light, heat and power.

2. That your Petitioner is the owner of a parcel of land bounding easterly on the Providence River and northerly on Point Street, in said City on which is situated its Manchester Street Generating Station; and is the owner of another parcel of land bounding easterly on the Providence River and southerly on said Point Street and which is part of a larger parcel of land on which is situated its South Street Generating Station.

3. That your Honorable Body, by virtue of the provisions of Chapter 1418 of the Public Laws of 1916 of the State of Rhode Island, is authorized to permit the owner or owners of estates situated upon opposite sides of a street or highway to build and maintain a subway, conduit or pipe under and across such street or highway. A copy of said Chapter 1418 is attached hereto as Exhibit A.

4. That in the operation of its Manchester Street and South Street generating stations your Petitioner requires a pipe line for the transmission of steam between these two stations and accordingly desires to install such a pipe line under and across Point Street for such purposes, all as shown on plan entitled "PROPOSED STEAM LINE AT POINT STREET BRIDGE IN PROVIDENCE RIVER AT PROVIDENCE, RHODE ISLAND APPLICATION OF THE NARRAGANSETT ELECTRIC COMPANY APRIL 28, 1958", attached hereto as Exhibit B.

WHEREFORE your Petitioner prays your Honorable Body to grant it permission and authority to construct, install, reconstruct, maintain, operate, repair, replace and inspect a pipe line, together with all necessary insulation, casings, fixtures, supports, attachments and appurtenances, for transmission and conveyance of steam between the Manchester Street and the South Street generating stations of your Petitioner, in the City of Providence, under and across Point Street, in said City, and to attach said pipe line, and as the same may be reconstructed, repaired or replaced, to the fixed portion of the westerly end of the Point Street Bridge structure, all to be substantially as shown on said plan, attached hereto as Exhibit B, and in conformity with approved and accepted standards for this type of construction.

Approved April 14, 1916

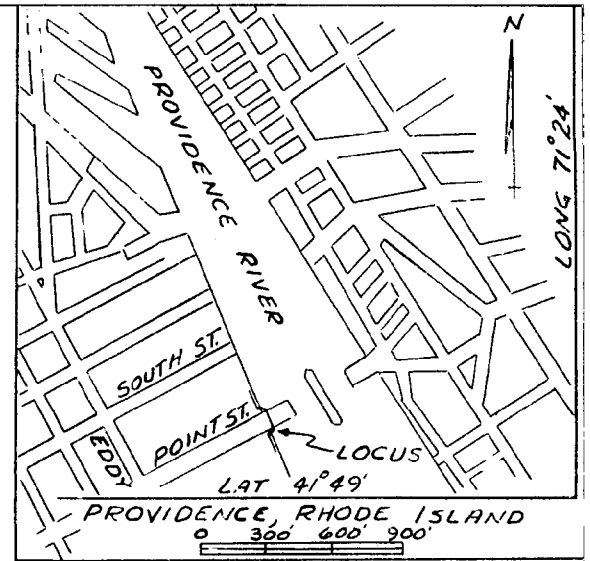
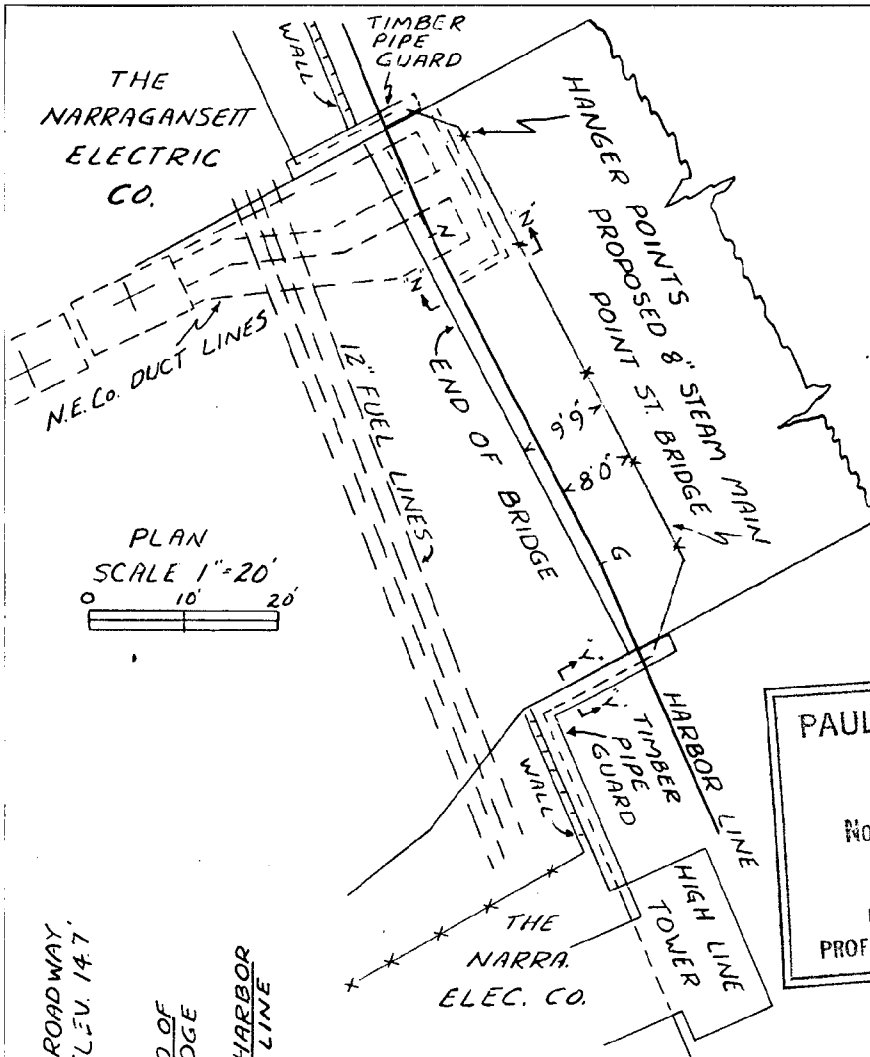
AN ACT AUTHORIZING THE CITY OF PROVIDENCE TO PERMIT THE OWNER OR OWNERS OF ESTATES SITUATED UPON OPPOSITE SIDES OF A STREET OR HIGHWAY TO BUILD AND MAINTAIN A SUBWAY, CONDUIT OR PIPE UNDER AND ACROSS SUCH STREET OR HIGHWAY.

It is enacted by the General Assembly as follows:

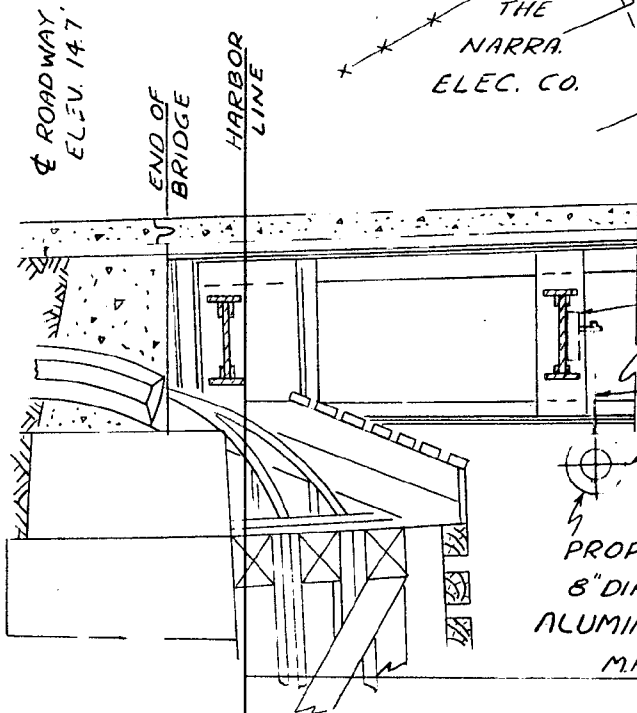
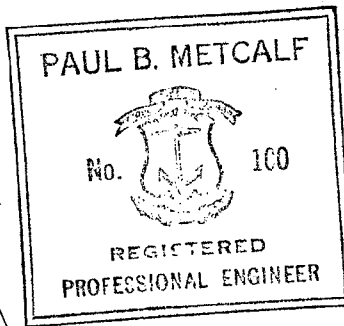
Section 1. The city of Providence from time to time by resolution of the city council may permit the owner or owners of estates situated upon opposite sides of a street or highway to build and maintain a subway, conduit or pipe under and across such street or highway for the purpose of connecting such estates. Any such subway, conduit or pipe may be used for any lawful purpose, including the transmission of the products of petroleum or any compound thereof, as said city council shall permit. Every permit granted under the provisions hereof shall be upon the condition that such subway, conduit or pipe shall be laid under the supervision and control and to the satisfaction of the commissioner of public works; and upon the condition that such subway, conduit or pipe shall be removed upon ninety days' previous notice from the city council whenever in the opinion of said city council the public interest may require the removal thereof; and upon the condition that in case the city of Providence shall at any time hereafter be authorized to assess abutting owners for the private use and occupation of the public highways, the permission granted shall not in any manner affect the right of the city to charge and collect rent for the use of such street or highway, or for maintaining therein such subway, conduit or pipe; and upon the condition that such owner or owners shall hold and keep said city of Providence harmless, safe and indemnified from and against loss, cost, damage, payment and expense on account of any injuries to persons or damage to property for which said city may become liable on account of the laying, construction, maintenance, use or repair, or neglect properly to maintain or repair, or any defect of such subway, conduit or pipe under and across such street or highway, unless the wrongful act or negligence of said city, its officers or employees, shall cause such injury or damage as is mentioned aforesaid; and upon condition that such owner or owners, before commencing the work of laying such subway, conduit or pipe, shall file a bond for such amount as the city council shall determine, in form satisfactory to the city solicitor, to hold and keep said city harmless, safe and indemnified as aforesaid, but said bond shall not be construed or held to limit the general obligation of such owner or owners to hold and keep said city harmless, safe and indemnified as aforesaid; and upon the condition that such owner or owners shall repair and keep in repair so much of such street or highway and the sidewalks thereof at and near where such subway, conduit or pipe crosses the same as shall be required by the commissioner of public works and to his satisfaction, and also upon such other and further conditions as said city council shall see fit to impose.

Sec. 2. This act shall take effect upon its passage.
