
Dear Councilman Lombardi,

We are also applying for expansion of premises from Prov. Bureau Of Licences. We will also seek permission from Dept. of Public Works and the Parks Dept.

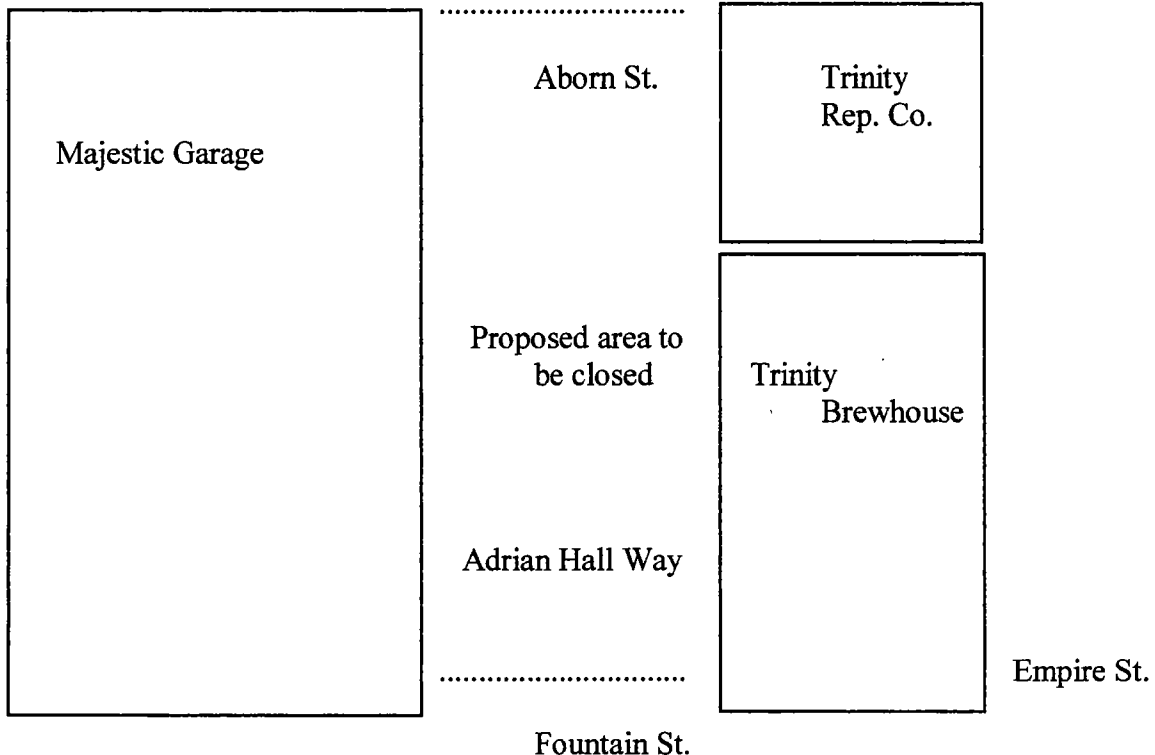


