

RESOLUTION OF THE CITY COUNCIL

No. 122

Approved February 9, 1995

WHEREAS, a parcel of land located at the Port of Providence, as described in Resolution No. 432, approved on January 3, 1916 and attached hereto was conveyed to the City of Providence; and

WHEREAS, Resolution No. 432 stated that the Park Commissioners are authorized and directed to take the care and custody of the same; and

WHEREAS, The Board of Parks Commissioners approved the transfer of the parcel to Prov Port, Inc., at meeting held on September 19, 1994; and

WHEREAS, The Board of Park Commissioners deemed that the conveyance of the parcel was not detrimental to the Parks Department or to the citizens of Providence; and

WHEREAS, The parcel is in a central location within an industrial area.

NOW THEREFORE, BE IT RESOLVED, that said parcel has ceased to be useful for park or municipal purposes;

NOW THEREFORE, BE IT FURTHER RESOLVED, That His Honor the Mayor is hereby authorized to ratify the action taken by the Board of Park Commissioners and execute any and all documents relative to the transfer of said parcel; provided; however, that in any such transfer the City shall reserve for itself or for the benefit of a designee any use agreement easement or right of way necessary to provide public utilities conveniences or services in the same manner as may now be supplied.

No. 432. Resolution Dedicating Certain Land on Fields Point Estate for Public Park Purposes.
(Mr. Knowles.)

(Approved January 3, 1916.)

RESOLVED, That the certain tract of land belonging to the City of Providence, namely, that portion of the Fields Point Estate, so-called, bounded and described as follows: Beginning for the southwesterly corner thereof at the northeasterly corner of Fort avenue and New York avenue; thence northerly, bounding westerly on said Fort avenue 650 feet to a corner; thence turning a right angle and running easterly 300 feet; thence turning a right angle and running southerly 650 feet to said New York avenue; thence turning a right angle and running westerly, bounding southerly on said New York avenue 300 feet to the point of beginning, said tract containing 195,000 square feet, and shaded yellow on the accompanying plat entitled, "City Engineer's Office, City Property Department, November 18, 1915, 041391," be and the same is hereby dedicated for public park purposes, and the Park Commissioners are hereby authorized and directed to take the care and custody of the same, and to make such provision for the improvement of the same as they shall deem necessary.

No. 433. Resolution Remitting Certain Sewer Assessments, Viz.: Margaret A. Whelan and John P. Fogarty and Wife. (Mr. Baker.)

RESOLVED, That to the following named persons, the sums set opposite their names be remitted, or if already paid, be re-
