WHEREAS, the Providence Youth Progress Board, Inc., was constituted in 1962 to provide greater opportunity for the youth of Providence and has recently broadened its functions and enlarged its scope and has been re-named Progress for Providence, Inc.; and

WHEREAS, the Economic Opportunity Act of 1964 was enacted and designed by Congress to provide technical and financial assistance for urban communities to fight poverty and unemployment and their causes; and

WHEREAS, Federal assistance under this Act depends on the City's determination, as evidenced by a Community Action Program, so-called, to mobilize its resources and develop and execute plans and programs of sufficient scope to substantially diminish or eliminate the causes of poverty; and

WHEREAS, the Board of Directors of Progress for Providence, Inc. is composed of conscientious, capable leaders in business, labor, education, religion, social service, and government, who are concerned with the welfare and progress of Providence; and

WHEREAS, the Honorable Joseph A. Doorley, Jr., Mayor of Providence, did, on January 12, 1965, officially proclaim and designate Progress for Providence, Inc. as the agency charged with and responsible for the planning, execution, and administration of a Community Action Program for the City of Providence;
