No. 375

Approved August 5, 1960.

Whereas, the State of Rhode Island and in particular the Metropolitan Providence area is presently experiencing a severe polio epidemic; and

WHEREAS, Community cooperation with City and State Health Authorities is essential if the epidemic is to be halted; and

WHEREAS, the Providence Journal-Bulletin has done an outstanding service in providing leadership in setting up anti-polio clinics and forcibly bringing to the attention of the general public through its newspaper columns and radio facilities, the necessity of every individual securing Salk anti-polio inoculations and cooperating with public Health Authorities; and

WHEREAS, scores of individuals in our Community have also come to the forefront to assist in the fight against polio including doctors, nurses, suppliers of medical supplies, the American Red Cross and many others; and

WHEREAS, Edward A. Anderson, Chief Medical Officer of the Quonset Point Naval Air Station has performed an especially meritorious service to our Community over and beyond the call of his duties as a Naval medical officer in carrying out a mass immunization program with the aid of his hypospray injector gun.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Providence, does hereby in behalf of the people of this City extend its appreciation and commendation to the Providence Journal-Bulletin, the American Red Cross, the doctors, nurses, suppliers and all others who have joined in the fight against the polio epidemic and who have made any contribution to said fight and a special "Well-done" to Captain Edward A. Anderson, U.S.N., and be it further

RESOLVED, that a copy of the within resolution be forwarded to the Providence Journal-Bulletin, the local chapter of the Red Cross, the Rhode Island Medical Society, Captain Edward A. Anderson, U.S.N. and the Commanding Officer of the Quonset Point Naval Air Station.

Whereas, William J. Maguire, former Superintendent of Public Buildings of the City of Providence, passed away July 6, 1960, and

Whereas, Mr. Maguire, after graduating from Massachusetts Institute of Technology, was for many years engaged in the construction business as an engineer for the Charles B. Maguire Company which his father had founded. He became Superintendent of Public Buildings March 16, 1933 and served until July 2, 1936 when he resigned to accept a presidential appointment as Director for the Rhode Island Public Works Administration which entailed the supervision of a multi-million dollar State building program in the late 1930's. When P.W.A. operations were consolidated in regional offices, he became senior engineer in the New York regional office, returning to Rhode Island as Director in 1938. From 1941 until his retirement last year, he was Superintendent of Public Buildings in this city.

His long association in the construction field and his membership in Tyler Council, Knights of Columbus, the Society of Professional Engineers and the Turks Head Club, earned him a host of friends and acquaintances who mourn his death.

Now, Therefore, Be It Resolved that His Honor, Mayor Walter H. Reynolds, and the members of this city council take this occasion to honor the memory of their associate and extend to Mrs. Maguire and her family their sincere sympathy.
